Topic Original Report

MO: By entering unoccupied house and removing copper pipe in an attempt to steal it.

MO: By being in possession of tools used to commit a theft.

On 7/10/08, at 0322 Hrs., INV. DEUCHER and I were detailed to 1333 Hall on a complaint from COM/ZOLTAN RAFFAI stating the house was vacant and he saw what appeared to be flashlight shinning in the house.

On arrival we observed the front door was opened. We asked for additional cars, and PO. DE. MCCARTHY and PO. MINTEER arrived to assist. INV. DEUCHER and I began to clear the house. The front door was damaged. The deadbolt was bent, and the door frame was split. The interior of the house was gutted and obviously unoccupied. We entered the basement and observed the copper pipe was missing. INV. DEUCHER and I entered the attic. While in the attic I observed some insulation in the Northeast corner that appeared to disturbed. I pulled back the insulation and discovered a male hiding. I ordered him to crawl out onto the floor and he complied. He was wearing one work glove. I located a black duffel bag behind the male. He was secured in handcuffs, and advised he was under arrest for Breaking and entering. The male identified himself as ARA/MICHAEL CROSBY.

The duffel bag contained the listed tools and sixteen pounds of copper pipe. I advised CROSBY of his Miranda rights and he stated he understood. He stated to this officer that all the pipe in the bag was from the home we arrested him in. He further advised he was in Lakewood recently to visit a friend and observed that 1333 Hall was vacant. He stated he didn't know the friends name or address. CROSBY stated he took the bus to Lakewood to steal the copper pipe out of the house. CROSBY was transported to LPD and booked in by PO. MISCH and PO. DEMCCARTHY for Breaking and entering and Possession of Criminal tools. CROSBY has a CCH BCI#B283234 and FBI#360406KA9.

Dispatch checked in CAD and advised me that the last known owner of the home is OWN/KIMBERLY DUMMERMUTH. I was unable to locate a current OBT for her. INV. DEUCHER took photos of the basement, bag of copper, and the damaged door. The listed tools and gloves were tagged and secured in locker #7 in the property room. The bag of copper was weighed, tagged, and secured in locker #8 in the property room.
