N A R R A T I V E 1	<p>Topic Original Report</p> <p>M.O.: By punching and stepping on the victim's face causing physical harm.</p> <p>Sgt. KAUCHECK Sir;</p> <p>On 7/11/08, at 1711 Hrs, cars were detailed to the area of Madison and Quail on a report of a fight. Upon officer's arrival, we were unable to locate anyone claiming to be involved in a fight.</p> <p>At 2107 hrs., I was detailed to 2113 Quail to speak to the male that was claiming to be assaulted behind Madison Bi-Rite earlier. Upon my arrival, I spoke to COM/ANGELA ROBINSON who advised that her son, VIC/ , was the one assaulted. In speaking to , he advised he was sitting on a metal book located by the back door to Madison Bi-Rite when SUS/"STREETS" came running up to him and started to punch him. was unsure where "STREETS" came from. advised "STREETS" punched him about 5 times to his face. advised he was knocked to the ground. Once on the ground, advised "STREETS" stepped on his face. "STREETS" then got in the driver's side rear seat of a black vehicle and left the area.</p> <p>advised he does not know "STREETS" real name. advised he knows "STREETS" from the neighborhood and believes he may live in the area of Halstead and Athens. described "STREETS" as a black male about 6' tall, weighing around 150 pounds and 18 or 19 years old. "STREETS" also has a Mohawk. See the victim's attached statement for details.</p> <p>In looking at , the left side of his face and eye were slightly swollen. I asked if he saw the officers earlier. stated he did. I asked why he did stop the officers and advise them what happened. ROBINSON advised her son was too afraid. ROBINSON and I both advised they desire prosecution for the Assault. Officer FIORITTO responded and took photos of . Both ROBINSON and I advised they believe Madison Bi-Rite has a security camera by the back door and it may have recorded the Assault. At the time of the report, Madison Bi-Rite was closed.</p>
