Topic Original Report

MO: By brandishing a razor knife and threatening the victim with it in an attempt to steal his property.

On 7/11/08, at 0326 Hrs., officers were detailed to the area of W. Clifton and Detroit on a call from VIC/ROBERT EYNON stating he had been assaulted. On arrival I spoke with EYNON and WIT/ROBERT TRIVETT and learned the following.

EYNON stated he was walking home from the bar. He was cutting through the Donatos parking lot when two males approached him. EYNON said the males started acting aggressive. He said he can't remember exactly what they asked for but he thinks they told him to give them the beer he was carrying. EYNON refused to give the males anything. EYNON stated both males pulled razor knives from their pockets. The males said the knives were infected with HIV. EYNON stated he got scared and started to run. He said the males began to chase him and he fell causing a small scrape on his right knee and left cheek. EYNON stated that TRIVETT stopped to see if he was alright and the males ran WB on Detroit. EYNON could not give a very good description of the males other than they both were white, short, and had small builds. He did remember that one of the males was wearing a black hoddie with the hood up. He further stated that the male with the hoodie was smaller than the other male. EYNON stated he did not need medical attention to treat his injuries.

TRIVETT stated he was on his way home from the store when he observed two males with knives attempt to stab EYNON in the Donatos parking lot. TRIVETT said EYNON began to run and the males chased him still brandishing the razor knives. He said he observed EYNON fall and he stopped to check on him. TRIVETT said the males saw him and ran WB on Detroit. TRIVETT stated he recognized one of the males as SUS/RYAN CHURCH. He said he was positive it was CHURCH because he went to Lakewood high with him a couple years ago. He said that CHURCH is a white male with short light brown hair and was wearing a white shirt. The only description he had of the other male is he was wearing a black hoodie with the hood up. Officers checked the area for suspects with negative results.

Dispatch could not find a RYAN CHURCH in the computer that matched the age we were looking for. INV. DEUCHER took photos of EYNON'S injuries. TRIVETT and EYNON provided written statements. EYNON stated he desired prosecution and was advised on the solvability factor.
