Topic Original Report

M.O. By writing "Streett Tag" with permanent marker on an Ameritech box.

On 7-12-08 at 0413 hours, WIT/JAMES HANNA called LPD stating that two males appeared to be spray painting an electrical box on Madison at Woodward. HANNA advised that one of the males was wearing red pants. P.O.CANTLIN located ARA/JEREMY KOTELES and OIV/COREY MUSCATELLO on Hilliard at Olive. KOTELES was wearing red pants.

INV.FIORITTO located the VIC/AMERITECH box on the SW corner of Woodward and Madison. INV.FIORITTO stated that someone used a fine point black permanent marker to write "STREETT TAG" on the box. INV.FIORITTO stated that it still had a fresh marker smell.

KOTELES indicated that he had two black markers in his pocket that he used to write on posters. He denied writing on anything else. P.O.RUSNAK brought HANNA to the scene and he positively identified KOTELES as the male who was writing on the box. HANNA provided a written statement to P.O.RUSNAK.

KOTELES was arrested for Criminal Mischief. A fine point and king size black Sharpie marker were located in his left pant pocket. I transported KOTELES to LPD where he was booked in by P.O.PERHACS. I gave him citation M40085. KOTELES shows to have a CCH, his FBI number is 894247VB5 and his BCI number is C070552. I tagged the markers and placed them down the property chute.

I contacted ATT/AMERITECH and they advised that they desired prosecution.
