Topic Original Report

Mo: By walking a Pit Bulldog on a city sidewalk without being muzzled or on a chain leash.

Mo: By kicking his dog after being cited for the above offense.

On 07/12/08, while on patrol WB on Franklin Blvd., I passed a male who was walking WB on the south sidewalk of Franklin Blvd. This male was walking a Pit Bulldog and it was not muzzled. I turned around and stopped this male in the area of Franklin and Ridgewood. I advised this male on why I was stopping him. This male was identified as, (ara) ISMAAIL H. ADAMS. ADAMS advised that he did not know his dog had to be muzzled or on a chain leash. Officer Lowther arrived as backup.

I remember that I had forwarded ADAMS address to the Animal Warden Office. I did this so they would follow up with the resident due to fact of a Pit Bull being there. On todays date, I called the Animal Wardens Office and I spoke to Animal Control Officer Michael Stewart. In speaking to Stewart, I learned that he responded to 1457 Winchester on 07/02/08. STEWART spoke to, (oiv) LINDSEY CARDINEL, on that date. Stewart had told CARDINEL about the cities ordnances and told her what needed to be done so she would be in compliance. STEWART advised that this dog is a six month old, male, Pit Bull and its name is ROCCO.

I advised ADAMS about the information I learned from STEWART. ADAMS advised that CARDINEL is his fiancee and he has not seen her for a week. ADAMS advised that he was gone for a week and he hadn't spoken to her at all.

I advised ADAMS that I was going to issue him a citation since the dog was not muzzled or on a chained leash. I issued ADAMS citation M38672 for Disposition of Dangerous Animals. ADAMS was released on citation. When ADAMS was walking away he tore up his ticket and he then kicked his dog. I yelled for ADAMS to stop and come back to our location. I had to yell at him a couple of times, but he finally stopped walking away and came back to our location.

I had ADAMS put ROCCO in the rear of 212. I then had ADAMS have a seat in the back of 208. I advised ADAMS that I was going to issue him a citation for Cruelty to Animals. ADAMS was asking why he was in trouble for kicking his own dog. I told ADAMS he kicked his dog for no reason and he said, "It's my dog". ADAMS kept saying that he shouldn't be getting in trouble for kicking his own dog. I then asked ADAMS that if he was with his fiancee and he hit her while he was walking away, should I ignore that? ADAMS stated no that's a person and this is just a dog, you can't compare the two.

I radioed to dispatch and asked them to have Animal Control Officer Stewart respond to our location. Upon Stewart's arrival, I advised Stewart of the above. Stewart advised that since the animal was being abused he would be impounding it.

I issued ADAMS citation M 38673 for Cruelty to Animals and he was released on citation. Once again ADAMS tore up his ticket.
