Topic Original Report

M.O: By punching the victim in the face and pushing him down onto the ground causing injury.

Sgt KAUCHECK Sir,

On 7/13/08, at 0211 Hrs, cars were detailed to Mccarthy's, 16918 Detroit, on the report of a male being assaulted.

Upon my arrival, I was meet by VIC/ SAMUEL FELLER and WITs/ MATTHEW MALLINAK and JONATHAN ROEBUCK. FELLER was bleeding from his mouth and he had a 1/2 inch laceration to the left check, by the corner of his mouth. FELLER advised he was at MCCARTHY's with his friends MALLINAK and ROEBUCK. They left the bar and started to walk West on Detroit when two males came up to them from behind. FELLER advised both males were white, one male was about 6'6" tall and at least 250 pounds, the other male was about 5'10" tall and muscular. FELLER advised that the shorter male started to yell at him about spitting on him in the bar. FELLER stated that they started to push him. The next thing he knew he was being carried back to Mccarthy's by his friends. See the attached statement for details. FELLER was asked if he spit on anyone at the bar. FELLER advised he did not, but there was water dropping from the air ducts and maybe the male was hit by water dripping from the air ducts. FELLER was transported to the Lakewood Hospital by LFD.

I spoke to both MALLINAK and ROEBUCK, who advised they left Mccarthy's and they walked West on Detroit, when two males stopped them. One male was around 6'5" tall weighing around 280 pounds and the other male was about 5'10" and muscular. These males started to yell at FELLER about spitting on him. The males started pushing FELLER. The next thing they knew, the shorter male punched FELLER in the face knocking him off balance. The larger male then pushed FELLER to the ground. The males then went back towards Mccarthy's. ROEBUCK and MALLINAK advised when FELLER landed on the ground he was unconscious. They picked FELLER up and brought him back to Mccarthy's to get help and to find the males that assaulted FELLER. See their attached statements for details. Both MALLINAK and ROEBUCK advised they believe they will recognize the males again when they see them. ROEBUCK and MALLINAK believe that the male that punched FELLER, did not have anything in his hand when he punched FELLER, but they were not sure.

SUS/ ERIK CLAXON, who matched the description of the larger male, was located behind Mccarthy's. Officer HAYES spoke to CLAXON who advised he was at the location of the assault. CLAXON advised he was at MCCARTHY's with his friend "WILL" and WILL's friend SUS/JOHN. CLAXON advised he does not know WILL's last name or his phone number. CLAXON advised JOHN and WILL followed three males outside and stopped them. CLAXON advised JOHN started yelling at FELLER, he was not exactly sure why. CLAXON advised a pushing match started between the two. CLAXON attempted to get between the two, but JOHN punched FELLER and FELLER fell. JOHN then left.

At the hospital, FELLER was going to be treated by Dr NELSON. Inv PICKENS responded and took a photo of FELLER's injury. At the time of the report, Dr NELSON had not seen FELLER. FELLER advised he believes he will recognize the males again if he sees them. FELLER advised he desires prosecution. FELLER signed the attached medical release. After I left the hospital, I responded back to the area of Mccarthy's to see if I could located the exact location of the assault, but I was unable to.
