Topic Original Report

MO1: Did knowingly cause another to believe that he will cause serious physical harm, by swinging a knife in a slashing fashion at the other person.

MO2: By having a 6 1/2" bladed knife concealed in the front of his pants.

On 07/13/08 at 1957 hrs., officers were detailed to the area of Webb and Northwood for a fight between several individuals, one of which had a knife. On arrival, I did not witness anyone fighting, just several males scattered throughout the intersection of the location. PTL HAYES and PTL ROMANELLO arrived on scene as well. Officers had all parties involved stop where they were, and all the people were subsequently searched for weapons. PTL HAYES located the listed knife in the front of a males pants, tucked behind his waistband, with the point of the knife pointing toward the ground. That male was immediately secured in handcuffs. None of the other parties involved had any weapons on their person.

The male with the knife was identified as (ARJ) . The parties that were with him were identified as (OIV) , and his girlfriend (OIV) . There were four males that arrived in the listed Chevrolet. They were (OWN)ZACHARY QUARLES, (OIV)ROMAN CARINGI, (OIV)KEVIN SKELLY, and (VIC)TIMOTHY PYLES. QUARLES gave officers consent to search his vehicle for weapons, but none were found.

I spoke to and who both stated that they were walking north on Webb with their friend , when the listed vehicle drove past. The driver, QUARLES, made several rude and obscene comments to which were not appreciated. QUARLES turned onto Northwood, stopped his car, and the four occupants exited. CARINGI and began to get into a verbal argument, which turned into a fist fight. While they were fighting, confronted QUARLES about his language and advised him that she was only 16. When she was confronting QUARLES, states that he put his hand on her right shoulder, at which time she pushed him away. She was angry, and began kicking the car.

states that he got into an argument with CARINGI, which turned into a fist fight which went into the front yard at 1346 Webb. When the fight was over, he saw QUARLES push into some shrubs. He confronted QUARLES, who head-butted in the mouth, breaking his upper front left tooth. retaliated by punching QUARLES. Officers arrived as the fight was ending.

QUARLES and PYLES stated that after QUARLES said "Hi" to threw something at the car, at which time QUARLES stopped the car and everybody exited. CARINGI and got into an argument, but PYLES said that punched CARINGI first, and the fight was on. PYLES said that while they were fighting, he saw approaching the two, so he stepped in front of him to stop him from getting involved. PYLES said that pulled the listed knife out of his pocket, said "I'll cut your throat", and swung it around in PYLES direction. then slid the knife across the ground, in an intimidating fashion. When neighbors came outside, put the knife back in his pocket, and began to fight with CARINGI until LPD arrived. PYLES stated that he thought that was going to kill him.

QUARLES said that began to kick his car, putting a large dent in the right rear quarter

panel. He pushed away from his vehicle, causing to loose her balance and fall into some nearby shrubs. By this time, and CARINGI finished fighting. confronted QUARLES, but officers arrived as the incident ended.

was read his Miranda Rights by PTL HAYES. agreed to talk to officers and stated that when CARINGI and began to fight, he found a knife laying in the northwest corner of Webb and Northwood, so he picked it up. said that PYLES and CARINGI saw him with the knife, so he put it back in his pocket, and started fighting with CARINGI until officers arrived. gave a written statement, but refused to sign it after being released from the handcuffs at LPD.

QUARLES, SKELLY, and CARINGI all contest that SKELLY and CARINGI were never in the car when the incident happened. They said that SKELLY and CARINGI were walking to the area where QUARLES was picking them up. Even after I advised them that I saw all four occupants in the vehicle at Webb and Clifton only two minutes prior to the call, they still denied being in the car. SKELLY gave a written statement saying he saw take the knife out of his pants, threaten PYLES, and scrape and slide the knife on the ground.

QUARLES agreed that since he was able to pop the dent out of his vehicle, and there appeared to be no additional damage, he would not pursue charges against stated that since QUARLES was not going to pursue charges for the damage to his vehicle, she would not pursue any for pushing her back and into the bushes.

CARINGI and agreed that it was a misunderstanding that got out of hand. They both declined to pursue charges against one another for the fight. PYLES gave a written statement about the incident and desires prosecution for Aggravated Menacing.

(WIT)VONA SMITH said that when she heard a commotion outside, she saw a group of people fighting. A male was in the middle of the street waiving a knife around, but was not going after anyone. began to kick QUARLES car, at which time QUARLES told her to stop and pushed her away. fell into the bushes. approached QUARLES, they started fighting, and officers arrived. SMITH provided a written statement.

was arrested for Aggravated Menacing and CCW. He was transported to LPD by myself, and booked in by CO MCCARTHY. INV ALLEN processed. was released to his uncle (OIV)TOMMIE GREER at the station. The knife was confiscated, tagged as evidence, and placed in locker #13 of the property room.
