Topic Original Report

MO - By taking victim's laptop computer equipment from a desk in the living room and leave with same without permission.

LT. WARNER, Sir;

On 071408, at 2112 Hrs., I was detailed to 1438 WAGAR AV. on report of laptop computer equipment stolen. Upon speaking to the VIC/TAYLOR J. NORTON-PENSYL, he advised having a Fourth of July party at his residence and sometime between the hours of 0430 and 0900, he woke to find his Sony Vaio laptop computer w/charger and its surge power strip missing from the desk in his living room.

TAYLOR said he had approx. 20-25 family and friends at the party and everyone had been drinking and several of the guests stayed overnight, having access to the computer equipment. TAYLOR spoke to the overnight guests and no one admitted to taking the computer equipment.

TAYLOR said he did not feel any of his family or close friends would have been responsible for the theft. TAYLOR felt the only possible suspect was, SUS/YUNES N. ASSAD, who TAYLOR only knows through a friend named, OIV/JOHN D. HEINA. TAYLOR also said YUNES was the only one who sleep over and was found gone early in the morning along with finding the laptop computer equipment gone.

No ET work was done due to the time that elapsed and the fact that nothing was disturbed on the desk where the computer equipment had been. TAYLOR does wish prosecution.

OAM entered the laptop computer into the Leads as stolen, NIC #A446319869.
