Topic Original Report

M.O. By entering duplex house by forcing lock on front door and removing copper pipes without owner's permission.

On 7-14-08 the victim of this report, MAHMOUD I. AMAWI, came to the station to report copper pipes stolen from his house at 1274 / 1270 Beach Ave.

AMAWI related that he owns the above duplex and is in the process of re-habing the place. He resides on the 1270 side some times. On 7-13-08 he had observed the lock on the front door of the 1274 side had been broken. He contacted the station and he and PO REBRACA checked the house and at that time nothing appeared missing or disturbed. The lock was re-secured.

On 7-14-08 the lock was again forced open and in checking the house this time, AMAWI found that all the copper pipe in the basement was taken, along with the pipes leading to the kitchens and some pipes leading to the second floors. Aside from the missing pipes, the house reportedly suffered considerable damage to the walls etc when the copper pipes were pulled from the walls. No suspects, victim will prosecute if a suspect is developed.

Inv. MALLOY was detailed to the house for ET work. Numerous photos were taken, no latent prints were found.
