Topic Original Report

- M.O. By stabbing VIC in the leg putting him at risk of serious physical harm.
- M.O. By having a 3 1/2" blade folding knife concealed in his left pocket.
- M.O. By being voluntarily intoxicated and stabbing another person causing harm.

On 7-17-08 at 0211 hours, Officers were detailed to the Riviera on the report of a male being stabbed. Dispatch advised that the suspect was wearing a blue/white striped shirt and khaki shorts. While enroute to the scene I observed a male later identified as, WIT/STANLEY WATSON, at the corner of Spring Garden and Detroit. WATSON stated that he witnessed the fight and the male I was looking for was at Roycroft and Detroit. P.O.HAYES and P.O.CANTLIN located ARA/JOEL KODY at the corner of Roycroft and Detroit. See P.O.HAYES's supplement for details of the arrest.

I spoke with WATSON, WIT/BECKY WENDELN, WIT/TIMOTHY KILBANE and WIT/DAVID KOZYK. WATSON stated that KODY was being belligerent and groping WENDELN at the bar. He advised that he and KOZYK confronted KODY. WATSON stated that KODY started to threaten them stating he had guns. WATSON indicated that the security guard, VIC/ARTHUR SPEER, came towards them to see what was happening. He advised that SPEER tried to remove KODY from the bar, but KODY resisted and they started fighting on the floor. He indicated that KODY left the bar and that he observed that SPEER had blood on his hand. WATSON stated that he then pursued after KODY to see where he was going. WATSON was brought to KODY's location by INV.FIORITTO where he made a positive identification. I took a statement from WATSON.

WENDELN, KOZYK and KILBANE gave similar accounts as WATSON about what had transpired in the bar. WENDELN stated that KODY kept on grabbing her shoulder. She advised that she felt uncomfortable about it. WENDELN indicated that KODY was intoxicated. She advised that he did not grope her anywhere else.

KOZYK stated that he also chased after KODY. He advised that at one point KODY turned towards him and that he observed the knife in his hand. KOZYK stated that KODY was approx. twenty feet away from him and that KODY started to run towards him. KOZYK stated that he then ran away from KODY.

KILBANE indicated that he knew KODY from meeting him at the bar in the past. He advised that he knew he lived at the apartment building on the corner of Roycroft and Detroit.

P.O.PERHACS took a statement from SPEER. SPEER stated that he observed a pushing match between KODY and another male in the middle of the bar. SPEER stated that WENDELN stated that she was groped and he told KODY to "hold up." He advised that he felt a sting in his left leg and he then pushed KODY to the ground. SPEER stated that he observed that his leg was bleeding and he said that he got stabbed. SPEER indicated that KODY was then escorted out of the bar by other employees. SPEER desires prosecution. He advised that he did not want immediate medical attention but would go to the hospital later. P.O.PERHACS observed the stab wound on the upper left portion of

SPEER's left thigh. He advised that it was about 1 1/2" long. INV.FIORITTO took a photo of the injury.

P.O.HAYES indicated that he found the knife in KODY's left pocket. The blade measured 3 1/2". HAYES stated that KODY admitted to him that he stabbed SPEER because he felt threatened. HAYES transported KODY to LPD where he was booked in by P.O.RUSNAK for Fel.Assault, CCW-M and DCI. KODY does not have a CCH. HAYES tagged the knife and secured it in locker #11.

I later learned that SPEER went to Lakewood Hospital and was seen by DR.Gabrin.
