Topic Original Report

M.O. By brandishing a knife and causing the victim to believe that physical harm will be done.

On 07/17/08, at 2123 hours, officers were detailed check the area of Onondaga/Madison for two black juvenile males who brandished a knife to VIC/DYLAN W. BERNATH. He advised the males left northbound on Warren. BERNATH described the males to be black juveniles, wearing denim shorts. One of the males was wearing a white tank top, and the other a white t-shirt. One of the males was on a bicycle. He was the one to have the knife on his person.

Officers checked the area for the males, and I responded to speak with BERNATH at Belle/Madison. As I arrived on scene, P.O. GREEAR called out with a male at Warren/Hilliard, matching the description given. In speaking with BERNATH, I could detect a very slight odor of alcohol about his person. He advised the following:

BERNATH was walking eastbound on Madison from the Red Rose Cafe, 14810 Madison. When he approached the Marathon gas station at Onondaga/Madison, a black juvenile male approached him riding a dark colored bike. The juvenile was traveling westbound on Madison. BERNATH described him as dark complected, possibly in his teens, wearing blue jean shorts, and a white tank top. The juvenile had short hair, and little, to no facial hair. The juvenile asked "What are you looking at?" BERNATH replied, "What do you mean?" The male repeated himself, got off of his bike, and reached into his shorts pockets. BERNATH stated the male pulled out an object that looked to be a knife out of his pocket. During this time, another black juvenile male walked up to BERNATH. He was wearing a white T-shirt and jean shorts. This male was tall, and thin. This male did not say anything to BERNATH. BERNATH picked up his phone to call the police, and the males left running northbound on Warren.

I transported BERNATH to Warren/Hilliard to identify the male with P.O. GREEAR. When I arrived, there were two males on scene. While P.O. GREEAR was speaking with the juvenile identified as OIV/ , SUS/ , walked up to him. was wearing a black tank top, blue jean shorts, and a black bandana. is a black juvenile male, and was wearing a white tank top, and jean shorts. BERNATH positively identified . He stated was the male who brandished the knife. BERNATH was unable to provide a description of the knife. He was also the one supposedly riding the bicycle. BERNATH advised that was not involved.

advised P.O. GREEAR of the following:

was walking westbound on Madison, with his friend that was riding a bike. could not provide his friend's name. He stated that he plays basketball with him from time to time. He stated they walked past BERNATH around Onondaga/ Madison, and he started to yell at them. His friend got into an argument with BERNATH. stated he did not say a word to BERNATH. They felt BERNATH was picking a fight with them. They ran northbound on Warren. stated he did not know where his friend was. advised that he did not see his friend with a knife in his hand.

was walking on Warren when he saw another friend, , talking to the police. advised that he recently left his girlfriend's house on Elmwood. He provided a number for dispatch to contact. They spoke with a female who stated was at her residence today She could not say how long ago he left. was identified, and released on scene. A knife was not found on , or located

BERNATH provided a written statement of the above information. He desires prosecution.

P.O. RODA advised he was flagged down by a party who wanted to remain anonymous. They saw the altercation between BERNATH, [REDACTED], and the other juvenile male. They advised BERNATH was yelling at the juveniles, and it appeared that he was attempting to pick a fight with them.
