Topic Original Report

MO - By taking the victim's car keys and car without her knowledge or permission.

On 7-18-08, at 0434 Hrs., (VIC) SUSAN RIVERA called police to the Travelodge at 11837 Edgewater Dr. to report that a male she gave a ride to stole her car keys and car. P.O. GREEAR and I responded to the scene.

RIVERA was in room 102 with her boyfriend, (SUB) CHARLIE HALL. She advised the two of them picked up the listed suspect at Gas USA on West 117th near Trisket. She stated the suspect offered her ten dollars for a ride home. HALL stated the suspect told him he lived next to the Travelodge in apartment #205.

RIVERA advised that she parked her car in the rear parking lot of the Travelodge near the Lake Ave exit. She stated she went into the Travelodge and left HALL with the suspect in the parking lot.

RIVERA was in room 102 when HALL came in with the suspect. RIVERA stated that the suspect only came in to the room to borrow cigarettes.

RIVERA'S car keys were on a table next to the door where the suspect was standing. After getting some cigarettes, the suspect left. RIVERA noticed that her keys were gone off the table. RIVERA and HALL ran out to her car, but it was gone.

RIVERA stated she recently got the temporary tag for the vehicle and did not know what it was. An RS was done on RIVERA, but the vehicle in question could not be located. RIVERA did not have any paperwork for the vehicle and she stated most of it was in the car.

The vehicle could not be entered in the computer as stolen due to the lack of information provided. RIVERA was advised to find the pertinent information and return to the police department with it so the car could be entered.

HALL was found to have and active warrant out of (GOV) PARMA P.D. for failure to appear on a family offense. This warrant was confirmed with HUSHEA of PARMA P.D.

I transported HALL to Memphis Ave and Tiedeman Rd where he was turned over to P.O. KURTIN of the Parma P.D.
