Topic Original Report

MO #1-By being in possession of a glass pipe with suspected marijuana residue.
MO #2-By being in possession of a single Xanax tablet, a Schedule IV drug, without a valid prescription.

Detailed with Ptl. Piechowiak on 7-20-08 at about 1208 Hrs. to 1590 Ridgewood Ave. #7 to assist the landlord. The landlord, COM/PETER RAJKA, advised Dispatch that he wanted to do a welfare check on his tenant, OIV/DESARAE KIRK, as the last rent check from her had "bounced" and no one had heard from DESARAE in several months.

On arrival at the unit RAJKA gained access to the unit and announced his presence. At this time the unit was found to be in a poor condition with dishes piled high in the kitchen sink. Clothing and other items were also observed laying all around. This made the apartment nearly impassable.

In checking the bedroom, Officers located ARA/MICHAEL DUNLAP and ARA/LESLIE KIRK laying in bed. DUNLAP and LESLIE were advised on our reason for being in the unit. LESLIE stated that DESARAE was fine and was at work. LESLIE stated that DESARAE knows that she had a key to her apartment, however, she was unsure whether or not DESARAE knew that she and DUNLAP were at the apartment at this time. LESLIE claimed DESARAE has not lived in the unit in several months. LESLIE did not know where DESARAE was currently residing. Neither DUNLAP nor LESLIE were able to explain why they did not answer RAJKA's prior phone calls to the home or when he first announced moments ago that he was entering the apartment with Officers.

LESLIE then provided DESARAE's work OBT and she was contacted. While RAJKA was speaking to DESARAE about the civil matter regarding the apartment lease and her past due rent, Ptl. Piechowiak observed DUNLAP attempting to cover something up with a hat on the night stand adjacent to the bed they were seated in. Upon removing the hat Ptl. Piechowiak found the indexed drug pipe. Prior to asking anyone about the pipe, DUNLAP claimed he had smoked some tobacco out of it last night.

In checking the pipe, the odor of burnt marijuana was detected and some suspected residue was observed. DUNLAP was advised he would be cited for the Possession of Drug Paraphernalia. Since it is common for marijuana users to keep a supply of marijuana nearby, Ptl. Piechowiak checked a nearby open cigarette pack for further contraband. No other marijuana was found however the indexed pill was. In asking DUNLAP and LESLIE about the pill LESLIE claimed the pill was hers. LESLIE stated the pill was a Xanax she had received from an unidentified friend "for when she's stressed out or can't sleep". LESLIE further advised she does not have a prescription for the Xanax. Sgt. Favre was contacted about the matter and he advised that LESLIE should be cited for Drug Abuse (M).

DUNLAP was then issued citation #M39995 for Possession of Drug Paraphernalia. LESLIE was issued citation #M39996 for Drug Abuse (M). Both parties were then advised on their mandatory court date and released at the scene. RAJKA advised DUNLAP, LESLIE and DESARAE that they were being served a three day eviction notice unless the past due rent issue is resolved. It should also be noted that DUNLAP has a warrant entered for his arrest from GOV/ASHLAND COUNTY SO. The warrant for FTA/Petty Theft is out of the pick up radius.

The drug pipe and pill were then transported to the property room, tagged and secured in the property chute to be held as evidence. In later contacting Lakewood Hospital's Pharmacy, this Officer was advised by Cindy that the Xanax confiscated is a 2mg tablet and is also a Schedule IV drug.

In further checking LESLIE was not found to have a criminal history however, DUNLAP does. DUNLAP has FBI number 557385AC3, BCI number C139498 and Lakewood Identification number 22981.
