	<p>M.O. By grabbing victim by the wrists and attempting to pull her off of a stationary bicycle, then knocking victim to the floor and punching her in the right thigh.</p>	
	<p>On 7-20-08 at approx. 1015 hrs, the victim, LISA A. CULTRONA, came to the station to report being assaulted by her exercise instructor.</p>	
	<p>CULTRONA related that she and the suspect, EDWARD A. MEYER, had been friends as she has attended his classes for over a year. According to the victim, MEYER recently blamed her for his not being invited to a get-together the class had. MEYER had advised CULTRONA that she was no longer wanted in the class.</p>	
	<p>The victim had contacted the owner of the business, ANN WEIXEL, who reportedly advised her that she was a paying member and was able to attend.</p>	
	<p>On 7-18-08 the victim entered the work-out room and clipped her bike shoes onto the pedals and started exercising. MEYER saw her and walked up to her, started yelling at her and told her to get out, MEYER then grabbed CULTRONA by the wrists and attempted to pull her off the bike that she was attached to. CULTRONA along with the stationary bike fell to the floor and MEYER reportedly then punched her in the right thigh in an apparent attempt to knock one of her legs loose from the pedals.</p>	
<p>The victim stated she left the business and contacted the owner leaving a message about the incident, She did not hear back from WEIXEL and now intends to prosecute . CULTRONA has a large bruise on her right thigh. She stated the contusion has caused her considerable pain and she has been unable to participate in a couple of runs she had registered for over the weekend. She also has pain in her wrists from being pulled over. She did not seek medical attention.</p>		
<p>CULTRONA described the suspect as being high-strung and has been known to yell at the students, but as far as she knows, he has never injured anyone before. She stated that all of the class members present witnessed the incident and she could obtain names if necessary.</p>		
<p>A written statement was taken from the victim. This officer took several photos of the injury. A photo sheet was completed and the sheet and memory card were placed in the photo drop.</p>
