Topic Original Report

LT. SPRAGUE SIR:

Dispatched to 1485 Ridgewood Ave. on a report of a male being solicited to perform a "hit" on another person. On arrival, I was met by COM/KEVIN S. BOERIO who advised the following.

BOERIO advised that he has been using the Internet service provider Yahoo for approximately three months. A large portion of his use of the Internet involves speaking to other people in "chat rooms" as a way to meet other people in Ohio, particularly the Cleveland area. On today's date, he decided to join a chat room called "Ohio 10."

While he was in the "Ohio 10" chat room, another person engaged him in a conversation. This person's screen name is "WILL231820." BOERIO uses the screen name: "LUCKY THE GREYHOUND."

Very quickly in the chat, this male asks BOERIO if he is willing to drive to the Dayton, Ohio area to do some work. The male advises that the job to be performed involves illegal activities. BOERIO decided to engage this male in conversation and asked what type of work was to be performed. He also advises this male that he is a man of God and does not want to do anything illegal to make money.

The male soon advises that he is looking for someone who is willing to drive from Cleveland, Ohio to the Dayton, Ohio area to perform a murder. He also says that the person to be killed is a drug dealer. Toward the end of the conversation, the male asks BOERIO to send \$450.00 for supplies (gun, ammo, and directions). After receiving this money, then BOERIO will receive instructions on who to kill and how to do it. The male would send BOERIO \$10,000 as an advance and then once the person is killed, BOERIO will receive \$90,000. BOERIO then tells the male that he is not going to do this job and the conversation soon ends.

When BOERIO heard that he was being asked to send this person money, he then began to feel that this was nothing more than a scam to get cash from an unsuspecting chat room talker. After thinking about this for a while, he decided that it would be best to report this "chat" to the police in case the person is actually serious about hiring someone to commit a murder.

BOERIO was able to provide me with a copy of their online conversation. See that attachment for additional information. BOERIO was able to view this males online profile and learned that he is divorced, lives near Dayton, Ohio, and is 62 years old. That is assuming that all of the information he provided was factual.
