<b>N A R R A T I V E</b>	<b>1</b>	<p><b>Topic</b>                      Original Report</p>
<p><b>MO:</b> By leaving voicemail messages on the victims cell phone, threatening to do serious physical harm to the victim.</p> <p>On 07/22/08, at 2040 Hrs., (VIC)ROMA HORODYSKY-KOWCZ came to the front counter and stated the following:</p> <p>In January of 2008, (SUS)ANTHONY CIACCHI moved into the apartment building that she owns on Madison Ave. On several occasions, CIACCHI has made threats to her as well as several tenants, usually stemming from complaints about noise. In June, CIACCHI failed to make his rent payment, claiming he was ill and not working. HORODYSKY-KOWCZ eventually started an eviction, giving him a three day notice that the official eviction process would begin unless a payment was made. HORODYSKY-KOWCZ compromised with CIACCHI, accepting a \$120 payment in June, with a \$200 payment to be made each Friday throughout July, to catch up on his back rent.</p> <p>On Thursday, 07/17/08, she left a new three day notice prior to starting the eviction process due to her not receiving any payments since the \$120 in June. On this date, CIACCHI called HORODYSKY-KOWCZ and left what she described as a fearful, serious threat, leading her to believe that her life and safety was in jeopardy.</p> <p>HORODYSKY-KOWCZ played the voicemail that CIACCHI left on her cell phone at 1756 Hrs. In the voicemail left, CIACCHI says that HORODYSKY-KOWCZ "fucked his girlfriend and that he was going to take this to the limit", and that HORODYSKY-KOWCZ better get a city report. He says that if she comes to the apartment on 07/23/08 to "throw his shit out, he will fuck her up". He goes on to say that he will "shoot every guy that comes near", then says "I'll shoot you, mother fucker", referring to HORODYSKY-KOWCZ.</p> <p>HORODYSKY-KOWCZ stated that CIACCHI often gets drunk and is usually very violent and abusive when he is intoxicated. Again, she said that he has made several threats to her and the other tenants, who also fear for their safety.</p> <p>HORODYSKY-KOWCZ stated that she fears that due to the eviction notice left, and the eviction proceedings that will be filed on 07/23/08, that CIACCHI is capable of, and has the ability to, follow through with his threats, especially when the official eviction is served and is final.</p> <p>HORODYSKY-KOWCZ states that she will only go to the property when necessary, and for her protection, will try to do so with another male. She desires prosecution for the threatening phone calls, especially because of the threats and problems she has had in the past with CIACCHI.</p> <p>CIACCHI has a CCH showing FBI #67005V1, BCI #A949880, and Lakewood #10685, with an arrest/conviction for Aggravated Menacing/Stalking.</p>
