<b>N A R R A T I V E</b>	<b>1</b>	<p>Topic</p> <p style="text-align: center;">Original Report</p>	<p>On 7-23-08, I was detailed to 12500 Edgewater regarding a female who was chased by a male, in the parking lot of the Waterford Condominiums. Dispatch advised it was a white male in his early twenties who was last seen running south from 12500 Edgewater. Officers responded to the area to look for this male. P.O. GREEAR spoke with a female at the bus stop at Cove and Edgewater, who advised she saw a male run south on Cove and possibly turn into an apartment on the east side of Cove. Officers checked the area as well as the apartments on Cove but could not locate this male. I responded to 12500 to speak with COM/ANNA HLAVACS and learned the following.</p> <p>HLAVACS stated she was walking her dog on the northwest side of 12500 Edgewater. There is a small fenced area where you can take your dogs. Directly north there is a cement wall that overlooks the cliffs. There is about a 50 foot drop off to the ground. There are some steel beams that support the wall on the north side. HLAVACS stated she was watching her dog when a white male in his early twenties climbed over the break wall and came at her. HLAVACS stated she screamed and ran towards the condominiums. HLAVACS stated this male also began running after her. HLAVACS stated she made it to a door on the west side of the building and went inside. HLAVACS went into her residence and called LPD.</p> <p>HLAVACS stated she has never seen this male before and doesn't know how he could have gained access to the steel beams. HLAVACS stated there is video surveillance that monitors the northwest side of the condominiums. HLAVACS stated the building manager wouldn't be in until later to get a copy of the video.</p>
