Topic Original Report

MO1/ By pushing their way into an occupied structure and assaulting the resident.

MO2/ By being voluntarily intoxicated and a danger to himself.

On 7-23-08, at 2157 hours, PO Schad and I were detailed to 1498 W117th #22 on a report of a male that was assaulted by a neighbor. On arrival I was met at the street by VIC/DOBRA. DOBRA had blood running down the back of his head and his neck. He had an open wound on the back of his head. DOBRA declined medical attention.

DOBRA advised sometime around 2145 hours, ARA/RAMIREZ and SUS/SHULER knocked on his back door. He opened the door a crack to tell them to leave. Both males pushed their way into the DOBRA apartment. He told them to leave and they didn't. RAMIREZ and SCHULER called DOBRA a "snitch" due to reports he has made to the police in the past. DOBRA asked the two to leave and they didn't. SHULER grabbed DOBRA by the face and slammed the back of his head into the kitchen door frame causing injury. DOBRA began to yell for help, and the two males fled out the back door.

DOBRA desires prosecution. INV Mladek responded to the scene and took photos of DOBRA's injury.

While we were talking to DOBRA, RAMIREZ came walking by. DOBRA identified him as one of his attackers. RAMIREZ was intoxicated. He was unsteady of his feet and his eyes were bloodshot and glassy. He was placed under arrest for DCI and Agg. Burglary. RAMIRIEZ was advised of his rights and the waiver of rights. He stated he understood both and was willing to talk.

RAMIREZ stated and maintained that DOBRA, SHULER and RAMIEREZ were all friends. He said they went DOBRA's to drink. SHULER and DOBRA started arguing. SHULER grabbed DOBRA by the face and began pushing him back. RAMIREZ claims he left at this time, however DOBRA maintained that RAMIREZ was there as long as SHULER was. I later transported RAMIREZ to the station and booked him in jail with PO D. McCARTHY.

It should be noted that RAMIREZ's story changed a little as time went on. He at first claimed they were never in DOBRA's apartment. He change his story and advised the two were arguing outside. RAMIREZ changed it a third time to indicate it happened in the apartment.

We attempted to speak to SHULER at his residence. He refused to come to the door.

In checking with neighbors, INV MLADEK and I located WIT/COLLINS. COLLINS saw two males enter DOBRA's apartment. He stated it did not look like they forced their way in. He stated there was arguing coming from the apartment for 15-20 minutes before the two males left together. INV MLADEK obtained a statement from COLLINS.

PO SCHAD obtained a statement from DOBRA.
