Topic Original Report

Lt. Sprague, Sir:

On 07-23-08 I was detailed along with Ptl. Smykowski to Kauffman Park on a report of an assault to a juvenile. Upon arrival, we spoke with the mother of the juvenile, (COM)DONNA J. DOWELL, and she advised the following. Her son, (OIV) , and his friend, (OIV) , were assaulted by a B/M juvenile. There was no visible injuries on and had a small lump on the right side of his head. No medical attention was required.

advised he was at Kauffman Park with his friends and they said "Hi" to a couple of girls walking by. advised the female juveniles told him to "fuck off" and left the park. A short time later, a group of juvenile males approached them in the park and confronted and about the two juvenile females. They accused and of "flipping the bird" to the females and cursing at them. advised without provocation the juvenile male kicked him in the stomach and hit him with his fist on the left side of the face. became involved and was punched on the right side of his head. advised they never fought back and the males left. He then notified his mother by cell phone and advised her of the incident.

The juvenile male that struck and was described as a B/M, skinny build wearing a white t-shirt and baggy jeans. It was also believed he had a tattoo on his arm. The other males were described as W/M's, all wearing "wife beaters", and all had tattoos. Inv. Walling checked the area for the males and located the parties at 1326 Gladys sitting on the front steps. The juvenile males were identified as, (OIV) , (OIV) , and (OIV) . The juvenile females were also present and identified as twins, (OIV) and (OIV) . They were with a friend named, (OIV) .

and advised the following. They were at Kauffman Park playing with their friends when it appeared two males were trying to look down their shirts and up their skirts. The males were later identified as and by and told the males to stop and grabbed by the arm and said, "We are nice once you get to know us." advised she pulled her arm away. also advised that "flipped them off" and told them to "fuck off" when they were walking by. advised the same story. and went back to 1326 Gladys and told there brother, , about the incident with and

advised he went to Kauffman Park with and to speak with and advised that "faced off" with him and pushed him. then punched on the head. It was unclear on how became involved, but he was pushed on the ground by . They then left the park and went back home.

DONNA was unclear about prosecution at this time. She was advised that a Disturbance report would be completed about the incident. was also advised that a report would be on file detailing the incident.
