	M.O.: By entering house through unlocked door and taking camera and Nintendo Wii without owner's permission.	
	Sgt. Gannon, Sir:	
	On 07/25/2008, at 0349 hours, Inv. Register and I were detailed to 1536 Mars Ave. on the report of a burglary. On arrival, I met VIC/THOMAS J. WICKMARK. WICKMARK advised that he was in the process of moving out, doing so gradually over the past few days. On 07/24/2008, at approximately 0600 hours, WICKMARK left the house, shutting the front and rear doors, though leaving both remained unlocked.	
	On 07/24/2008, at approximately 1300 hours, WICKMARK returned home, and noticed that the front and rear doors were now both open. WICKMARK stated that his Nintendo Wii video game system, as well as his Kodak digital camera, were missing. Nothing else appeared to have been disturbed, and nothing further appeared to be missing.	
	WICKMARK indicated that he believes SUS/ , his next door neighbor, entered the house and took the items. WICKMARK explained that when he returned home on 07/24/2008, told him that his front door was open and unlocked. WICKMARK advised that , whom he only met a couple of months ago, appeared nervous while speaking with him. WICKMARK admitted, however, that he had no other basis for his suspicion, and had no other possible suspects.	
	We then spoke with , who was sleeping on the front porch to his house. advised that he noticed the front door was open and unlocked on 7/24/2008, but denied entering the house and taking the missing items. did not see anybody enter the house or anything suspicious, and was unable to provide information as to who may have been responsible.	
	Inv. Register processed the scene for evidentiary purposes.	
	WICKMARK desires prosecution in this matter. WICKMARK was advised regarding solvability.	
	Disp. Nickler entered the camera and Nintendo Wii into the computer as stolen.
