Topic Original Report

On 7-26-08, at approximately 2330 hrs, officers were detailed to the area of 2120 Robin on the report of a male with a gun. Prior to our arrival, dispatch advised that the male with the gun was a black male in a white shirt and had left the area in a black Ford Thunderbird. The male in the Thunderbird left the area and headed towards Madison.

At that time, Ptl. Schad was checking the area for the vehicle and observed the listed vehicle turn S/B onto Robin from Madison. Ptl. Cantlin, Ptl. Krems, and I were also in the area at that time and assisted Ptl. Schad stop the vehicle on Robin at Thrush. The driver of the vehicle, later identified as SUB/MICHAEL MCNULTY, was ordered out of the vehicle while we had our duty weapons drawn. MCNULTY was secured in handcuffs by Ptl. Schad and checked for weapons. No weapons were located on MCNULTY's person or the vehicle.

MCNULTY was advised of his Miranda rights at that time and stated that he was on his way from his house to a friends residence on Robin. According to MCNULTY, he left his residence in Rocky River and drove E/B on Hilliard to Madison. He then continued E/B on Madison to Robin and when he turned onto Robin, he was stopped by LPD. MCNULTY denied being anywhere near 2120 Robin prior to being stopped by officers.

Ptl. Krems and I then responded to 2120 Robin to speak to the complainants about the situation. We spoke with OIV/ ANDRICA FOSTER, OIV/ SHALESE PATTERSON, and OIV/ ANTOINETTE COLES, who were sitting on the front porch of 2120 Robin. According to FOSTER, they were sitting on the front porch and her boyfriend was with them. FOSTER only knows him as "ERIC", however. While they were talking, MCNULTY pulled up to the corner of Robin and Plover in his black Thunderbird. When he exited the vehicle, "ERIC" yelled that he had a gun and told everyone to run. "ERIC" also ran at that time. According to FOSTER, PATTERSON, and COLES, they all observed MCNULTY with some type of small black semi automatic hand gun. They stated that he had the gun in his hand and was holding it up against his waist when he exited the vehicle.

Once everyone ran from the area, MCNULTY got back into his vehicle and left the area. MCNULTY did not say anything to anyone and did not threaten anyone with the gun at that time. COLES immediately contacted LPD at that point.

FOSTER and PATTERSON stated that they knew MCNULTY's first name from having seen him hanging out in the neighborhood with other acquaintances of theirs. Ptl. Roda transported FOSTER, PATTERSON, and COLES to Ptl. Schad's location and they positively identified MCNULTY as the male who was at their residence with the gun.

In further speaking to FOSTER, she stated that she did not know where "ERIC" ran to and did not know why MCNULTY would be at 2120 Robin with a gun. We were not able to locate "ERIC" at that time as well.

In further speaking with MCNULTY, he still denied being anywhere near 2120 Robin prior to being stopped, but he did have an altercation with parties from that address earlier in the day at Madison park. MCNULTY stated that they exchanged words, but nothing more came from the altercation.

It should be noted that prior to personally speaking with FOSTER, PATTERSON, and COLES, dispatch stated that after the original complaint of seeing the male with the gun, COLES changed her story and said they thought they saw a gun when the male exited the vehicle.

At that time, MCNULTY was advised of the complaint and this report and released at the scene.
