Topic Original Report

On 7-26-08, at approximately 0416 hrs, Ptl. Krems and I were advised to respond to St. John Westshore ER to retrieve a rape kit they had completed for evidence in a possible sexual assault. At that time, we were advised that a female, SUB/ , had been in the ER reporting that she had possibly been sexually assaulted. The only information given at that time was that she could only remember that she was in several bars in Lakewood on 7-24-08 with some friends. At the end of the night she remembers getting into her vehicle. does not remember anything else until she woke up naked in a males bed. She was not sure where she was at.

This was relayed to Ptl. Krems and myself by RN Brandy Dimatteo, who had conducted the listed rape kit. Dimatteo stated that there were no signs of trauma to . Dimatteo also stated that was very hesitant for any further assistance by an advocate or police at that time. However, was advised that the police had to be notified of the situation. Once the rape kit was completed and was discharged from the ER, she left prior to LPD being notified of the situation.

Ptl. Krems and I took the completed and sealed rape kit into our possession at that time. It was tagged as evidence and secured in locker #11 of the property room.

At the time of this report, a message was left on 's voicemail for her to contact me regarding the incident. , however, had not returned my call and no further information was obtained at this point.
