Topic Original Report

On 7-28-08, I was detailed to the area of Madison and Arthur regarding several males fighting in the street. Dispatch advised that COM/MICHAEL MASTERS, was calling from 1690 Arthur and believed that some of the parties involved lived at 1684 Arthur. INV.ALLEN and I responded to the area of Madison and Arthur but did not locate anybody in the street. I responded to 1684 and spoke with two males. The males were identified as SUB/JUSTIN BAER and SUB/CHASE BURCHETT. Officers spoke with them and learned the following.

BAER and BURCHETT stated they drove to BP Gas with their girlfriends. BAER stated he went inside the store to buy some items while BURCHETT waited outside. When he exited the store, BAER stated his cousin, BURCHETT, was arguing with 5 males. BAER stated his girlfriend drove off because she didn't want to get involved in a fight. BAER and BURCHETT did not get into the vehicle but attempted to walk home. BAER and BURCHETT stated they walked west on Madison and were attacked and jumped from behind for no reason. BAER stated they ran to his residence on Arthur after getting assaulted.


While speaking with BAER and BURCHETT, MASTERS came outside and stated the following. MASTERS stated he called police after seeing BAER and BURCHETT running back and forth to Madison. He stated they were yelling and creating a disturbance for about 5 minutes.

BAER and BURCHETT stated they just ran straight home from BP Gas. While speaking with them, their stories kept changing and they were very uncooperative. BURCHETT stated there were only 3 males and would not answer any of our questions. Both parties refused to make a statement. BURCHETT stated all he wanted was medical attention. Squad 1 responded and took BURCHETT to the hospital for his injuries.

BURCHETT had a 1" laceration to his finger and stated his ribs were sore from being kicked. INV. ALLEN took photos BURCHETT'S injuries.

BAER advised he found a cell phone and knife on Madison Ave; that he thought belonged to the other party involved in the altercation. I did a super phone search on the cell phone. The computer showed that it belonged to OWN/MATTHEW KAYE. The cell phone checked NIF for stolen. The knife and phone were tagged and placed in locker #20 of LPD's secured storage facility.

BAER and BURCHETT advised the desire prosecution.
