

<p>MO:By taking the listed video game system from the residence without the owners permission.</p> <p>Lt Warner Sir:</p> <p>On 7/29/08 I was detailed to 2074 Lewis-up on the report that the house was burglarized and a video game system was missing.</p> <p>On arrival I spoke to VIC/MATTHEW LOGAN and OIV/DOUGLAS VANDREI. LOGAN said that he left his house at 1500 hrs and when he returned at 1730hrs the listed video game system was missing. LOGAN began to check with his roommates about the whereabouts of the system. VANDREI was not aware that it was missing.</p> <p>It was learned that another roommate, OIV/JOSHUA SMITH, was asleep in the house when LOGAN had left. SMITH advised that he awoke to the sound of SUS/RAYMOND EDGEHOUSE standing in his room laughing. EDGEHOUSE is a friend of VANDREI. SMITH said that EDGEHOUSE was looking for VANDREI but was advised by SMITH that he was not home. SMITH went back to sleep.</p> <p>LOGAN said that when he got home the video system was gone. LOGAN, VANDREI and SMITH all believe that EDGEHOUSE stole the Nintendo Wii system when he left the house. LOGAN, VANDREI and SMITH all agreed that they share an open door policy with their friends, meaning that people can come in and go out of the upstairs apt whenever they want. They realize now that this needs to change.</p> <p>LOGAN said that they want the video game system given back to them, but said that they will prosecute if it is not returned. I went to EDGEHOUSE'S house on Maile and spoke to his grandmother. She said that he was not home. She was given my information so that EDGEHOUSE could contact me about this report. At the time of the report EDGEHOUSE had not contacted me.</p>
