Topic Original Report

M.O.: By punching the victim in the eye causing physical harm.

Lt. WARNER Sir,

On 7/30/08, at approx. 2034 Hrs, I was flagged over by COM/ADIL ALTAEI at Elmwood and Madison. ALTAEI wanted to report that VIC/ was assaulted on 7/29/08. ALTAEI advised that he is a friend of KHALEEL's mother, OIV/ KHWATER NAYEF, who does not speak English very well.

In speaking to , he advised that about two weeks ago, SUS/ accused of either stealing or losing the pegs off of ' bicycle. advised he took the pegs off his bicycle and gave them to advised he does not know what happened to ' pegs or why accused him of taking or possibly losing them. advised that a couple days ago, came up to him and told that he owed him \$20 because of the lost pegs. On 7/29/08, came over to at GRANT Elementary School and asked him for the \$20. told that he was not going to give the money. punched in his left eye due to his demands.

advised he has had problems with hitting him in the past. would not say what happened other than threw a ball at him about two months ago. In looking at his left eye, it was turning black and it was swollen. I took a picture if 's eye. He did not request any medical attention. advised that when he was assaulted by WIT/ was at GRANT SCHOOL and he witnessed hit advised that he does not know 's address but stated he lives on Elmwood by the school.

We responded to 's home where I briefly spoke to NAYEF. NAYEF desires prosecution for the Assault. I was unable to get a written statement from because he advised he can not read or write English. I was unable to find anything on or in the computer.
