Topic Original Report

M.O. By breaking the basement window, cutting the screen, entering the victim's residence, and taking a television, satellite dish receiver, laptop computer, and printer without her knowledge or permission.

On 07/30/08, at 1951 hours, I was detailed to 1614 Rosewood, on a call from VIC/IBTISAM H. SALEH, stating that her house was broken into sometime today. On arrival, I learned the following:


SALEH left her residence around 0645 hours, on 07/30/08. She arrived home around 1930 hours. SALEH entered the residence through the garage. She walked into the living room a short time later, and noticed a few electronic items missing. She contacted the police.

The residence is a two bedroom, single story residence with a basement. There are doors to the residence off of the living room on the south side of the house, and on the east side off of the kitchen. All of them were locked and not tampered with. The patio door on the west side of the house, off of the dining room, was found closed, but unlocked. There is a ramp from the front of the residence that wraps around the south side to a back deck. The gate leading to the patio was unlatched. SALEH advised that it was latched when she left the residence this morning.

A 42" Panasonic flat screen television with the satellite dish receiver box was taken off of the stand on the west side of the room. A Hewlett Packard laptop computer and printer were taken off of the desk on the east side of the living room. SALEH was unable to provide the serial numbers for the above property.

INV. PICKENS arrived on scene. We found one of the basement windows taken off of the hinges on the west side of the house. The screen to that window was also cut. The window is located underneath the patio deck. The window was dirty and rusted. Photos were taken. Latents were attempted, but were not successful.

Nothing else in the residence was gone through or tampered with. SALEH could not provide any suspects. I checked with other residents in the area, but they had just arrived home, and could not provide any information. SALEH desires prosecution.
