Topic Original Report

M.O. By having stolen bicycle under his control/in his possession.

M.O. By giving false name and DOB to a police officer.

On 07/30/08, at approx. 1645hrs., I was s/b on Clarence approaching Athens. While driving toward Athens I observed three males involved in some kind of disturbance. In speaking to the males I learned that they were arguing over ownership of a bike. Own/Richard Gleason and Oiv/Sean Balogh, stated that Gleason's bike had been stolen earlier this date. They continued and said that they had been out looking for the bike when they spotted a black male riding it, e/b on Athens at Clarence. They approached the male and took the bike from him. The male willing gave the bike to them saying he found the bike. Gleason and Balogh state that it was at this point that I arrived.

I spoke to the other male involved, later identified as Ara/James Brown, and learned the following. Brown said that he was at Circle K gas station on Lkwd. Hts. when he found the listed bike he was riding. He stated that he had just found it and took it so that he could ride it home and not have to walk there. Brown stated that he did not know the bike was stolen and that he did not steal the bike from Gleason. It is to be noted that when I asked Brown for his min. infor. he gave me his name as Aka/Jason G. Brown and a DOB of 07/17/90. When run through the computer this infor. came back nif. I asked Brown again for his information and he now gave the name of Aka/Jason J. Brown with a DOB of

I further spoke to Gleason and asked from where and when was his bike stolen, and why he didn't report it to us. Gleason stated that he was at 2103 Lewis painting the house. He had parked the listed bike in that address' driveway at approx. 0900hrs.. He noticed that the bike was missing sometime between 1130 and 1145hrs.. He further stated that he did not make a report at that time because he had to finish painting the house. He figured he would go look for the bike after work and if he did not find it, he would make a police report on it. Gleason stated that he wishes prosecution for the theft of his bike.

I again spoke to Brown and asked what time he found the bike. Brown, this time stated that he had just found the bike a couple of mins. prior to Gleason and Balogh confronting him. I asked Brown why he was e/b on Athens with the bike when he had told me that he was just using it to get home. Brown had no answer. I told Brown that he was under arrest for RSP and Giving false infor.. He was placed in Car #209.

In checking the bike for a Lkwd. bike lic. and a serial number I was unable to locate either. It appeared that the serial number was removed from the front of the bike frame(front tube) by unknown means. I asked Gleason when he had gotten the bike and why there was no lic. or serial number on it. Gleason stated that approx. three weeks ago he purchased the bike from a co-worker named "John". Gleason further said that he did not get a lic. on it because he just did not have the time. I asked him if he had any proof of ownership for the bike, and he said he did not. I told him that I would be impounding the bike until he could prove ownership. Gleason was unable to give any further infor. on the co-worker he purchased the bike from. The bike board checked negative for the listed bike.

The bike was tagged and placed in LPD property. Brown was transported to LPD and booked in by
