Topic Original Report

M.O. By threatening to fight VIC causing fear of physical harm and by repeatedly calling and leaving threatening and sexual text messages causing the VIC distress.

On 7-30-08, at 2054 hours, VIC/ came to the front counter with her parents to report that she was almost attacked by three other juveniles. was emotional and visibly shaken. stated that she was at the corner of Detroit and Gladys at 1930 hours when she observed SUS/ SUS/ and OIV/ across from her on the south side of Detroit. stated that and began taunting her. She advised that stated "your such a little bitch, don't be such a little pussy, come over and fight us." advised that as she walked towards Warren they followed her. She advised that she then walked back WB to the Phoenix Coffee House where an adult told her to stay and call for her parents. indicated that they taunted her as they followed. She advised that she was in fear that they were going to attack her. stated that she desires prosecution.

stated that pushed her down the stairs at Garfield school during a basketball game in April of 2008. She advised that the school handled the incident and that it was not reported to the police. does not know 's last name or if 's name is spelled correctly.

She advised that she has been receiving constant text messages and phone calls from and . She advised that they are all threatening and sometimes included comments of sexual nature. advised that her cell phone memory card was damaged and that she does have the messages anymore. She advised that her service provider is T-Mobile. She was advised to save any future messages and to make a log of the calls. stated that she received a message from on 7-30-08 at 2027. stated "I want to settle this." advised that the message came from cell number 216-316-
