Topic Original Report

MO: By breaking a window to gain entry to a church, then taking a computer and monitor without the owner's permission.

Lt. SPRAGUE Sir;

Dispatched to VIC/COVE UNITED METHODIST CHURCH on the report of items missing. On arrival, COM/FRANK GLIHA advised the following:

GLIHA arrived at the church this morning around 0845 to do some work. He immediately noticed that the secretary's office was in a state of disarray and a window was broken. He then called LPD. GLIHA said that no one has been in the office since 7/30/08 around 1200. GLIHA said there was a boyscout meeting at the church from 1930-2100 last night, but the meeting was confined to the basement.

The suspect(s) gained entry by breaking out a window measuring 20"x13". The window is located along the Western wall of the church and leads into the secretary's office. The area is fairly well obscured by high plant growth and is separated from the neighboring houses by 6' fencing.

Nothing was found in the area that may have been used to break the window. Broken glass was found on the ground outside of the window as well as on the floor in the office. The office had various items and papers that had been thrown off of the desk and onto the floor. An alarm clock and pencil sharpener that had been inside of the office were located on the ground outside of the building.

The computer and monitor had been sitting on a desk in the office. Neither GLIHA or the church secretary could provide any further description. It should be noted that GLIHA contacted her by phone while I was on scene. GLIHA advised that the pastor is new, and also would not have anything further. GLIHA could not think of any suspects. He desires prosecution and was advised of solvability.

Inv. MOHER processed the scene. He was able to locate a partial foot print on some of the broken glass. See his ET/Photo sheets for further.

It should be noted that the screen for the window was found torn and sitting on the ground outside of the church. There was a second screen from a window just North of the entry point that had also been damaged and removed. There was no obvious damage to that second window.
