Topic Original Report

MO - By striking the victim in the head with a large piece of brick causing physical harm.

On 7-31-08, at 0029 Hrs., (COM) ERICA FOSTER called the police to her apartment at 12521 Plover #3 to report that her boyfriend, (VIC) SEAN JONES, was hit in the head with a brick. Dispatch had a hard time getting suspect information from ERICA. The only thing obtained was that two black males were involved.

I responded to the scene with P.O. RUSNAK. P.O. RUSNAK checked the area for the suspects but with negative results. I spoke with JONES who advised the following:

JONES lives in the apartment with his girlfriend, ERICA. ERICA's daughter, (OIV) ANDRICA, and her boyfriend, (SUS) DAVID ANDERSON, also live there. JONES only knows ANDRICA's boyfriend as (AKA) "TEEWEE."

At 0015 Hrs., ERICA and ANDRICA were having a verbal argument about the electric bill being too high. ANDRICA started calling ERICA a "bitch" and "liar." JONES stated that "TEEWEE" jumped into the argument and was also calling ERICA a "bitch."

JONES had enough and told "TEEWEE" to get out of ERICA's face. JONES stated that he also told him to leave. "TEEWEE" left the apartment.

JONES stated that "TEEWEE" returned ten minutes later and was standing just outside the apartment door. He started yelling at JONES that he could not tell him what to say or when to leave. JONES stated that "TEEWEE" started yelling again.

JONES went outside and "TEEWEE" pushed him. At that point, he was hit with a hard object in the back of his head by someone standing behind him. JONES did not see who struck him. He became dizzy and started bleeding. JONES did not see the suspects leave the area.

ANDRICA was not cooperative and stated she did not know "TEEWEE's" real name. She stated she did not see who the other males that were with him.

In looking at JONES, he had a 2" laceration on the back of his head that was bleeding. His head was starting to swell around the location. SQUAD 3 responded to the scene. Lakewood Paramedics transported JONES to the Lakewood Hospital E.R.

I spoke with ERICA and she advised she saw the entire incident. ERICA stated that "TEEWEE's" real name is in fact DAVID ANDERSON. She stated that the two males that were with ANDERSON were (SUS) RODGER and (SUS) "STREETS."

ERICA gave a birthday for ANDERSON but had no additional information on "RODGER" or "STREETS." She did stated that "RODGER" and "STREETS" hang out in the area of Robin St. She stated that she saw a brick thrown at JONES' head but could not say who actually threw it. She stated that everyone ran W/B on Plover after the incident.

In looking around where the attack occurred, a multicolored brick was found on the ground outside of the apartment door. ERICA confirmed that in fact was the brick that was used on JONES.

I took photographs of the brick. It was confiscated and tagged as evidence. It was placed into locker #23 in the property room.

I responded to the hospital where JONES was being treated. I took photographs of his injuries. JONES provided a written statement of the incident. He desires prosecution and a T.P.O.

JONES signed the medical release form. He was being treated by DR. HASTINGS and had to get twelve stitches. He was later released.
