**Topic**

M.O. By punching and kicking victim about his person, causing physical harm while taking his cell phones and \$100.00 cash.

Lt. Sprague, sir,

On 08/01/2008 at 1247 hours, I was detailed to 1536 Ridgewood to take a robbery report. Upon arrival I spoke to VIC/ JEFFREY A. GORDON, who advised the following:

GORDON stated, at around 0130 hours on 08/01/2008 he was "jumped" by four black males. GORDON advised he was walking E/B on Franklin near 12405 Franklin talking on his cell phone, when a group of four black males asked him for a cigarette. GORDON stated when he went to get the cigarette he was punched on the face, fell to the ground, and was kicked and punched repeatedly while on the ground. GORDON advised they then took his blackberry and moto-q cell phones, and \$100.00 dollars cash out of his wallet. GORDON stated he got up off the ground and began to walk W/B on Franklin back to his house at \_\_\_\_\_, but was followed and continuously attacked by the four black males. GORDON stated he eventually made it home and went to sleep.

GORDON stated he had been drinking and doesn't remember much about the incident. The only description GORDON could remember about the group was there were four black males, in their late twenties to early 30's, about 5'09"- 5'11" tall, and were all about 215-235lbs. GORDON stated he believes the group resides at 12405 Franklin, because he sees the group in that area during the week. GORDON could not remember any other details about the incident.

GORDON stated his only injuries were his black and blue right eye and his entire body ached but there were no other visible injuries. GORDON did not seek medical attention or call LPD because he was drinking and didn't think we could find the suspects because of his vague descriptions. GORDON advised he already has replacement phones and realizes the low solvability factor of this incident. GORDON stated he wanted this documented for the purposes of the cell phone company. GORDON's right eye was photographed. GORDON desires prosecution at this time.
