Topic Original Report

MO-By breaking the lock and hasp from door and enter the home of the victim, without permission to do so.

Detailed on 8-2-08, at about 1735 Hrs., to 2120 Robin St. on the report of several black juvenile males breaking into the basement there. COM/BONNIE SPEARS stated she observed the males enter the basement herself. SPEARS also stated that she knows the landlord, OIV/VICKIE ZANGARA, from previous encounters. SPEARS stated ZANGARA had placed a hasp and lock on the side door that leads to the basement entrance for the tenant in unit #2 because of prior break ins.

On my arrival, I found that this entrance in question is on the west side of the building. I advised Ptl. Pietch and Ptl. Beno over the radio of this information as they were also en route to the scene to assist.

While waiting for other Officers to arrive, I observed OIV/ leaving from the front door of unit #1 at the building. I asked SPEARS if was one of the juveniles involved with the break in. SPEARS stated she was not sure. was then stopped by this Officer as he attempted to leave the scene on a bicycle. Ptl. Beno arrived and began to identify and speak with about his actions at this time. Ptl. Pietch and I then proceeded to the side door SPEARS had observed the suspects enter.

While walking to that location, Officers observed the front door glass broken out to #2. The layout of the building is as follows. The building is a side by side unit with unit #1 at the far east end of the building and unit #2 on the west. Both of these units are on the first floor. Unit #3 is accessible from a central staircase between these two units but is located on the second floor. Unit #4 is located at the far west end of the building, also on the second floor.

It should be noted that, at first, it was unknown where the entrances and exits for the basement were and if it were possible for to be involved.

In checking the side door SPEARS saw the group enter, Officers observed broken wood pieces lying on the ground. The lock was still attached to the hasp but the hasp and corresponding screws were removed from the frame. Officers found that the side door handle lock had now been secured.

Ptl. Pietch covered this door while I attempted to gain access to the basement via the front door to unit #2. As I began to do this, Ptl. Pietch advised two parties had come upstairs from the basement of unit #2 to his location voluntarily. Ptl. Pietch ordered them against the wall where they were secured. Both of these parties were seated on the ground briefly until a patrol car could be pulled up the street for them to be detained in. These first two parties were identified as ARJ/ and ARJ/ and were then escorted over to car 203 until a complete sweep of the home was done. A short time later, ARJ/ and ARJ/ were also removed from the basement by Ptl. Pietch and this Officer. and were later escorted over to car 219 until Officers had determined if any more parties were inside. A thorough search of the home did not locate any other suspects hiding inside.

It should be noted that the indexed ring was found directly where had been seated prior to being placed in car 203. This ring was confiscated and later tagged and placed in the property

room until it could be identified by the victim.

While Officers were attempting to sort out the details related to this incident, this Officer was approached by OIV/ [redacted] stated that the unit the males were all removed from was her mother's, VIC/JORENE KIMBROUGH. [redacted] stated she was visiting a friend down the street when the incident first occurred. Since that time she had returned home and observed LPD on scene and found that the incident had taken place at her home. JORENE was then contacted by telephone. JORENE was found to be at work at this time.

In speaking with [redacted], JORENE was advised on who LPD was detaining at this time. JORENE stated that she only knows one of the males that was stopped by Officers but declined to identify who that was. JORENE stated she would be unable to leave from work to come view the ring but believed it may be hers. JORENE stated she would check for other damage and missing property as soon as possible but could not do so at this time. JORENE also stated that there was no damage done to either the front or side door when she left for work this morning. JORENE stated that she does desire prosecution in this matter. If anything else in the home was later found to have been damaged or missing, she would report it to this Officer.

At this point, [redacted], [redacted], and [redacted] were all advised they were under arrest for Burglary. SPEARS later provided the attached statement. In further speaking with Sgt. L. Wilkins about this incident, it was determined that only the parties SPEARS observed going into the home would be processed. This was later found to be [redacted] and [redacted]. Those parties were then transported to LPD by this Officer. Ptl. Pietch and CO Bunner later booked them into Jail. Ptl. Beno transported [redacted] and [redacted] to the rear of LPD where they were both eventually released to [redacted]'s mother, OIV/ANGELA ROBINSON.

Inv. Walling then responded to the scene and took photos of the damage done both to the front and side door. See his photo sheet for details.

Also note, although all of the juveniles arrested know [redacted] personally, they collectively denied that he was involved in the Burglary in any way. [redacted] was later released to his guardian at the scene, OIV/MICHAEL DUNLAP.
