Topic Original Report

MO: By being involved in a disturbance that created alarm to others. Persisting to yell and cause a disturbance after reasonable requests by police to desist.

On 8/3/08, at 0218 Hrs., officers were detailed to 1572 Hopkins on a anonymous call of a fight. On arrival officers observed several people on the front lawn arguing. The majority of the parties calmed down or dispersed when officers arrived. The home owner ARA/VALENCIA JONES GREEN was yelling and causing a disturbance in officers presence. VALENCIA was advised by officers several times to be stop yelling and to calm down. VALENCIA persisted on yelling and causing a disturbance. She was advised she was under arrest for Disorderly conduct (M4) and secured in the back of unit #212.

While on scene ARA/RICHARD JONES was also yelling and causing a disturbance. I advised RICHARD numerous times to stop yelling or he was going to be arrested. RICHARD continued to yell and disturb neighbors. He was advised he was under arrest for Disorderly conduct (M4) and secured in unit #214. After VALENCIA and RICHARD finally calmed down I learned that they are brother and sister. They both advised they were at a family cookout all day at VALENCIA'S residence. They said the disturbance was over family issues.

RICHARD has a warrant out of GOV/BROOKPARK PD for contempt of court. The warrant was confirmed by Sinclair and she advised they would place a holder. He was transported to LPD and booked in by PO. DE. MCCARTHY and I for the Disorderly conduct and the warrant. While at the booking window RICHARD was issued criminal citation #M40909 for Disorderly conduct.

VALENCIA was transported to the front counter of LPD by PO. BROWN. While at the front counter VALENCIA was issued criminal citation #M41652 for Disorderly conduct. VALENCIA posted bond and was released on citation.
