NARRATIVE 1	Topic	Original Report
<p>M.O.: By entering the vacant residence, and taking copper pipe and an air conditioner without the owners knowledge or consent.</p> <p>On 8/7/08, at 1930 Hrs, Inv. Mladek and I responded to 1568 Warren regarding a residence that was broken into. When I arrived on scene, I spoke with COM/LILY JANKE and learned the following:</p> <p>JANKE indicated sometime in July, when showing the house, she found items were missing. She did not contact the police at this time because she was unsure what the company in charge of the property wanted to do. It wasn't until today she learned VIC/KEYSTONE ASSET MANAGEMENT wanted a report filed, and desired prosecution.</p> <p>JANKE is unsure of the exact date she found the items missing. There was no evidence of forced entry on any of the doors. The northern most window, located to the rear of the house, was found unlocked and slightly opened. A wooden bench, located inside underneath this window, had dried mud smudged on it. Approximately 50' in copper pipe was taken from the basement of the home, and an air condition unit was taken from the back yard. The unit was located against the north west corner of the home.</p> <p>Inv. Mladek processed the scene but found nothing of evidentiary value.</p>
