<p>MO:By forcing entry into the church and taking keys without the owner's permission.</p> <p style="text-align: center;">Sgt. WYNALEK Sir;</p> <p>Dispatched to VIC/COVE UNITED METHODIST CHURCH on the report of the church being broken into overnight. On arrival, COM/FRANK GLIHA advised the following:</p> <p>He arrived at the church this morning to do some work. Once inside, he noticed the windows in the secretary's office had been broken out. He then contacted LPD. It should be noted that the church was broken into on 7/31/08 with the same point of entry. See report #08-006325 for further.</p> <p>There are two windows measuring 20"x13" that lead into the secretary's office. The windows are located along the West side of the building. They are hidden from the neighboring residences by fences and shrubs. The Southern window was completely shattered and pushed inwards, but not broken out. The Northern window had been completely broken out, and pieces of glass were located inside of the secretary's office. Nothing was found that may have been used to break the windows.</p> <p>There was a small amount of blood just inside of the Northern window. Inv. MOHER later collected it as evidence. See his ET/Photo sheets for further. GLIHA has no suspects and was advised of solvability. He said that prosecution would be desired if a suspect is found.</p> <p>The only items missing were approximately 8 keys that had been hanging on some peg board. The board was located in a hallway just South of the secretary's office. The keys will not open the main doors to the church, however, they will open various things in the church such as the food cupboards, pop machine, garage, etc.</p>
