1	NARRATIVE	<p>Topic Original Report</p> <p>M.O. - By exposing genitals and masturbating in a public place, in clear view of the victim.</p> <p>On 8/9/08, at approximately 0321 hrs, at 13341 Madison, VIC/ SHARON M. RADIC stopped Ptl Hayes to report that a naked man had ran into the building. Upon speaking with RADIC the following was learned:</p> <p>RADIC stated that she had just left the laundromat and was passing in front of 13341 Madison on her way home. As she passed the address, she witnessed a man in the doorway who was completely naked from head to toe, and was masturbating. RADIC stated that when she had asked him what he was doing, he grunted and continued masturbating. RADIC then saw Ptl. Hayes and began flagging him down to advise him of the situation. At that time, the male ran into 13341 Madison, which is an empty office space.</p> <p>Ptl. Hayes, Ptl. Krems, and I checked the interior of the office and found no one inside. The rear door to the office was unlocked. It led to the parking lot behind the building, and to a couple of apartment doors. The suspect was unable to be located at this time. There was no damage noticed and the building was secured prior to our departure.</p> <p>RADIC stated that she was shocked and offended by the males behavior, and desires prosecution, should the suspect be located. She also stated that she would probably be able to recognize the male again, but had never seen him prior to this incident.</p> <p>We notified Larry Eiletz of BSO/ Victory Property Management, and advised him of the situation. At this time he desires no further police involvement.</p>
