Topic Original Report

M.O. By cutting screen and entering home through unlocked back window and taking jewelry

On 8-12-08 at 0728 hours cars were detailed to 17622 Lakewood Hts on report from VIC/CHARLENE MILETI that her home had been broken into last night. Upon arrival, MILETI advised she went to bed around 2130 hours last night and woke up this morning to leave around 0700 hours. MILETI had left her purse on the kitchen counter and it was not there when she went to leave. MILETI walked outside to see if she left it in her car. When she went outside she found her purse and the contents dumped onto the ground just outside a first floor north facing back yard window.

The window was left unlocked and open approximately six inches last night. The window faces north and the backyard is completely fenced in and is not visible from the street. It appears the suspect cut the screen in two places and pulled out the pins to remove the screen and then entered through this window.

MILETI was asleep upstairs when this occurred but did not hear anything unusual. The purse and contents were found on the ground just outside of the window the suspect entered. The only things missing from the purse were the three listed rings. The rings were bought as a set and were gold with diamonds and sapphires on them. They are size 6(1/2) or 7. There was nothing else missing or disturbed from the residence. Photographs of the stolen rings were obtained and they were tagged and placed in the property room.

The entry gate on the east side of the home was unlatched. MILETI advised the gate is hard to use and it is never unlatched. If the suspect entered through that gate, they would have seen the open window as they reached the northeast corner of the home.

Inv. Walling responded to the scene. See his E.T. sheet for additional information.

MILETI advised she desires prosecution.

Residences in the area were checked for any additional information. 17800, 17718, 17616, 17612, 17521, 17603, 17609 Lakewood Hts all checked ok. 17700 and 17602 Lakewood Hts both had back yard gates open. Upon speaking to OIV/BARBARA MICHEL at 17720 Lakewood Hts, she advised she returned home from vacation on 8-10-08 and found the listed key broken off in the back door handle of her home. MICHEL advised that entry was not gained to her home and she has no idea where the key came from or who may have tried to gain entry to her home. The key was confiscated, tagged, and placed in the property room.

Several area neighbors mentioned OIV/ABDELAZIZ OULHINT as a person they believe may be responsible for the burglary. OULHINT was said to drive up and down the street taking things from neighbors tree lawns and acts very suspicious at times. Inv. Walling and I responded to 17816 Lakewood Hts where he lives with his girlfriend, OIV/LORITA GREEN. GREEN answered the door and

[REDACTED] was very uncooperative with officers. GREEN refused any information on OULHINT or to say if he was home at the time. OULHINT has an extensive CCH.

Upon checking other residences, there was a vehicle entered at 17507 Lakewood Hts. See original report #08-006682 for additional information. A vehicle at 17511 Lakewood Hts was found unlocked and appeared to have been gone through, but the residents were found to be on vacation. See original report #08-006684 for additional information. I spoke to OIV/CATHERINE BUTLER at 17517 Lakewood Hts who advised she found a patio chair placed directly under her open unlocked rear kitchen window this morning. She advised that entry was not gained to her home and there was no damage.
