Topic Original Report

M.O. By entering a locked residence, and taking a television, several laptop computers, Ipod's, gift cards, and currency without the knowledge, or permission of the victims.

On 08/14/08, at 1913 hours, I was detailed to 16801 Hilliard, on a call from VIC/WILLIAM R. MEADEMA stating that his house was broken into sometime today. On arrival, I learned the following:

MEADEMA, VIC/NATHANIEL K. JONES, and VIC/ROBERT V. VITRANO live in the downstairs portion of the duplex residence. You enter the residence immediately into the living room from the front door. Straght ahead is the dining room, that leads into the kitchen. Off of the dining room is JONES and VITRANO's bedroom. MEADEMA's bedroom is separated from their's by a bathroom. They advised that the front and rear door to the common hallway is never locked, but their actual door to the residence is always locked. There was no sign of forced entry.

MEADEMA advised the landlord SUS/CHRISTINA E. ROZAKIS, is a family friend's daughter. He stated the family allowed the three males to stay at the residence for the summer while they were on break from school. They did not sign a lease, and do not have to pay rent. MEADEMA stated this was a problem with ROZAKIS. MEADEMA, JONES, and VITRANO are currently in the process of moving out of the residence.

MEADEMA advised they all had left the residence by 0900 hours today. MEADEMA and JONES arrived home at 1900 hours. They entered through the rear door. JONES advised the door was locked. They saw that the 40" Toshiba flat screen television was no longer in the living room, and thought VITRANO had started to move his items out of the residence. They contacted VITRANO. He advised that he was at work, and had not started to move his things from the residence. MEADEMA and JONES started to check around the residence, and noticed some items missing. MEADEMA contacted the police. Shortly after, VITRANO arrived home.

JONES advised the following items were taken:

A MAC Apple Lap top computer in a black case was taken from his bedroom. The case was on the floor against the computer desk. A white Apple Ipod was taken from the desk. The speakers to the IPOD were also taken . The speakers were sitting on the dining room table immediately outside of the bedroom. JONES advised that \$170.00 of miscellaneous currency was taken that was inside of the lap top computer case.

MEADEMA advised the following items were taken:

A Dell lap top computer and a black Apple Ipod with a case were taken from his desk along the north wall of his bedroom.

VITRANO advised the following items were taken:

A Toshiba 40" flat screen television, from the living room. His MAC Apple laptop computer was also taken from the living room coffee table. Miscellaneous store gift cards were taken from his wallet, but cash and credit cards were not tampered with.

None of them could provide serial numbers for the above listed items. INV. PICKENS arrived on scene. MEADEMA advised when they arrived home, both front and rear doors were still locked. ROZAKIS and SUS/ROBERT S. WELDAY are the only other people with a key to the residence. WELDAY lived at the residence prior to MEADEMA, JONES, and VITRANO moving in. They are all friends. MEADEMA advised that WELDAY came over to the residence sometime today to retrieve his laundry from the basement. He does not believe that WELDAY would have any reason to come into the actual residence. They have had problems in the past with ROZAKIS, but only over rent issues that were agreed upon with her parents.

INV PICKENS and I checked the residence for another possible point of entry/exit. We located a window on the first floor, on the east side of the house, with the screen partially up. This window leads to JONES and VITRANO's room. VITRANO advised this window is kept locked, and the screen was down. Photos were taken. Latents were attempted on the window, and were successful. See INV PICKENS supplement for details.

MEADEMA has a dog in the residence. I spoke with neighbors to the east and west who were home during the day. They advised they did not see anything, or hear the dog continuously barking during that time period. The resident upstairs was not home the entire day either.

MEADEMA, JONES, and VITRANO desire prosecution. I was unable to make contact with ROZAKIS and WELDAY at this time.
