Topic Original Report

M.O. By punching VIC's face causing physical harm.

On 8-15-08, at 0340 hours, Officers were detailed to the Days Inn room 131 on the report of a female that was assaulted by her boyfriend. On arrival, P.O. ORTIZ and I confronted SUS/BRIAN DILL in the lobby. DILL initially indicated that he did not know why Officers were speaking with him. I secured DILL with handcuffs until I investigated the incident further. I advised DILL of his Miranda Rights and he stated that he understood them. P.O. GREEAR and P.O. KREMS spoke with DILL while I went to room 131.

In speaking with VIC/ S in room 131, I learned that she was at a concert with DILL and that they had an argument. S stated that the argument continued when they got to the room. She advised that DILL struck her face with a closed fist and that she scratched him back. S stated that DILL then left for few minutes. DILL came back to the room and they started arguing again. S stated that DILL struck her again and she ran out of the room screaming for help. S was given a phone from a male in room 132, later identified as OIV/TREVOR TEW.

I observed that S 's cheeks were slightly red. She advised that she did not want medical attention. She indicated that she desired prosecution for assault. S provided a written statement.

I spoke with TEW about what he observed. TEW stated that he was awakened by an argument coming from room 131. He advised that he then heard a female yelling for help in the hallway. TEW stated that he handed S his phone to call the police.

I learned from P.O. GREEAR and KREMS that DILL gave his statement of what transpired. DILL indicated that they had an argument and that he started to pack his belongings. DILL advised that S became upset and attacked him. DILL advised that he did not want medical attention or prosecution. He stated that he called the police. See DILL's written statement for further.

I observed that DILL had some scratches to the back of his neck and head. INV. PICKENS took photos of both DILL's and S 's injuries.

Dispatch advised that they did not receive a call from DILL or CECOM.
