	<p>On 8-15-08 at 1304 hours I was flagged down by a male who wished to make an anonymous complaint. He advised around 1200 hours on today's date, a red Mercury Marquis pulled into the drive of 2081 Halstead with a young w/m driver. Another young w/m walked out of the down apartment onto the porch of 2081 Halstead. The driver of the vehicle yelled several times for the male who came out of the house to put the gun back in the house. After yelling several times, the male walked back into the house and came back out a couple minutes later and walked up to the front passenger window of the vehicle. They talked for a minute and then the driver began to yell at the male to get into the car. The male was hesitant but got into the car and it then left n/b on Halstead.</p>
	<p>The complainant advised he did not call police at the time because he didn't want to get involved but is now worried about there being drug problems at the residence. He also advised he observes that vehicle pull into that residence on a regular basis.</p>
	<p>Ptl. Robinson and I responded to 2081 Halstead and spoke to SUB/DOUGLAS HOTZ. HOTZ advised his friend, SUB/ _____, has a red Mercury and is over at his house quite frequently. HOTZ denied the incident as reported and said he does not have a gun in his possession and has never spoken to _____ about a gun. HOTZ appeared nervous while speaking to officers.</p> <p>_____ lives and _____ Coutant but there was no answer at the residence. The vehicle was not in the drive or in the area. The computer checked NIF for the vehicle.</p>
