Topic Original Report

MO: By punching the victim, with a closed fist, in his left eye causing him physical harm:

MO: By being voluntarily intoxicated, having bloodshot/glassy eyes, slurred speech, unsteady on her feet, strong odor of an alcoholic beverage on her breath, and getting involved in a physical altercation at the bar; all causing her to be a risk of harm to herself and others.

Lt. Warner, Sir:

On 08/16/2008, at 0154 hours, we were on patrol westbound on Madison when we were flagged over by a male at the corner of Elbur and Madison. At the same time I observed a blond haired female running across the street with a construction sign. We turned our patrol car around and pulled up to the male. He advised that the female had punched him in the face and she was now running south on Elbur from Madison.

We observed a female run to the backyard of 2013 Elbur. We found the female in the backyard. The female had a strong odor of an alcoholic beverage on her breath, her eyes were bloodshot/glassy, and her speech was slurred. The female was placed under arrest for DCI. She was identified as ARA/ JULIE STASIK. She was secured in the rear seat of unit 220.

We spoke to the male. He was identified as VIC/ CRAIG BOOTHE. He advised the following: he was inside the Lakewood Village Tavern and STASIK had been making comments to him all night. He does not personally know her. He advised that without provocation, she punched him in the left eye. I observed redness and swelling to BOOTHE'S left cheek bone. BOOTHE advised that he desires prosecution for the assault. He provided a written statement. He advised that he did not need medical attention. Ptl. Leanza photographed his injuries.


We spoke to the WIT/JENNIFER HICKS. She is the bartender at the Lakewood Village. She advised that she witnessed STASIK punch BOOTHE in the face. She advised that she told STASIK that she had to leave the bar.

We spoke to STASIK about the incident. She advised that BOOTHE had been picking on her and she admitted to punching him in the face. She was advised that she would be listed as a suspect in the assault against BOOTHE.

The sign that STASIK was seen carrying was a construction sign posted on Elbur at Madison. The sign advised, "Construction Ahead". The sign was not damaged and was left at the corner of Elbur and Madison.

We spoke to the resident of 2013 Elbur to see if she desired prosecution for trespassing. She declined prosecution.

STASIK was transported to the station. She was booked by Ptl. W. McCarthy for DCI. She was issued citation #M41753. STASIK, again, admitted to punching BOOTHE in the face at the booking

window. A copy of the booking tape was tagged as evidence and secured in locker #10 in the property room.

It should be noted that STASIK has a CCH which includes priors for resisting arrest and DCI (FBI #697722JC8 and BCI #C285922).

RR: Index City of Lakewood as victim of DCI and BOOTHE as victim of assault. Index STASIK as ARA for DCI and she was a suspect for assault.
