Topic Original Report

MO: By knocking the victim to the ground and taking his wallet and his cell phone.

Lt. Warner, Sir:

On 8/16/08, at 0538 hours, PTL GAMPFER was detailed to Warren to speak with a male that claimed to have been robbed on Franklin. PTL GAMPFER advised dispatch that she would be taking the male to the area of Franklin and Cohasset. PTL MAURER and I responded to the area.

We spoke to the male and he advised the following: He was identified as VIC/ RONALD DUPAL. He stated that he had been bar hopping in Cleveland and was walking home to Warren on Franklin. He stated that he was walking west on Franklin on the south side of the street. He stated that a Hispanic male with short black hair and a stocky build was riding a bike behind him. He stated that the male kept asking him what time it was and where he was going. He stated that he did not answer the male. He stated that the next thing he remembered was the male pulling his bike in front of him and knocking him to the ground. He stated that while he was on the ground, he pulled out his cell phone to call 911. He stated that another unknown male was behind him and he grabbed the phone. He advised that the male in front of him rolled him over and the two unknown males went through his pockets and took his wallet from his rear pocket. DUPAL was face down on the ground and did not see the second male. He did not see where the two males went after he was robbed.

DUPAL advised that he was highly intoxicated. He stated that he would not have been able to resist the males due to his condition. He could not describe the bike that the Hispanic male was riding. He could only describe the Hispanic male as having a stocky build with short black hair. He could not give a clothing description. DUPAL stated that the males did not say anything to him while he was being robbed and he did not see a weapon.

DUPAL advised that the last street sign he recalled seeing on Franklin before being jumped was Grace. He stated that, after he was robbed, he recalled seeing the playground equipment at Lewis and Franklin as he was running west on Franklin. He went home and called his brother, OIV/ JOHNATHON DUPAL. His brother picked him up and took him to Bay Village where he cancelled his credit cards. He did not have his credit card information on scene. His brother took him back home to Lakewood and that is when he called LPD. DUPAL stated that he was not sure if he could recognize the Hispanic male again. He advised that he desires prosecution.

Taken from DUPAL was a brown tri-fold wallet, his driver's license, a Visa card, a Charter One Bank card, and his black flip phone. He did not know the make or model of the cell phone. He stated that AT&T is the cell phone provider.

It should be noted that I took a report on 8/4/08 involving similar circumstances of an intoxicated male that claimed to have been robbed at Cohasset and Madison (see report #08-006434 for further). That night, INV REGISTER and PTL MINTTEER stopped two males in that area on Madison. Those males were identified as JOSE DIAZ and . They denied any involvement in the
