Topic Original Report

Lt. Warner, Sir:

On 08/16/2008 at 1918 hours a juvenile female came to the front counter accompanied by an adult female who stated a rape had taken place. The juvenile female was identified as COM/ [redacted] is a sixteen year old juvenile. We spoke to her in the detective bureau. [redacted] stated that she had been seeing a twenty-nine year old male named Willie. He also goes by the nickname, "Black". [redacted] did not know his last name. [redacted] advised that he is the same male that she was with when she was stopped by LPD on 08/12/2008 (see report #08-006673). The male was identified as SUB/ WILLIE CRENSHAW.

We asked how they met. [redacted] stated that she met him one day after Life Skills School. He was outside of the apartment building next to the school and introduced himself to her. They exchanged telephone numbers. [redacted] stated that she told CRENSHAW that she was only sixteen when he asked how old she was. They started talking on the phone. CRENSHAW suggested that they meet and [redacted] agreed. They met in Lakewood and walked to the area of W. 112th Street off of Detroit in Cleveland. They then took a cab to one of CRENSHAW's friend's house in Cleveland. She did not know the name of CRENSHAW's friend. They were the only two people at the house.

CRENSHAW asked [redacted] if she did drugs. [redacted] stated that she did and he asked what kind of drugs. [redacted] stated that she smokes "weed" and has taken "X". CRENSHAW advised [redacted] that she doesn't have to do or take anything that she doesn't want to take. CRENSHAW and [redacted] took an ecstasy pill and they smoked marijuana. [redacted] then told CRENSHAW that she wanted to have sex. According to [redacted], CRENSHAW was hesitant, but still engaged in sexual intercourse. [redacted] stated that they had sex two times that night. This event took place on 07/26/2008. This was also the first time the two of them had sexual intercourse. [redacted] advised that she was not raped.

[redacted] stated that they have had sex about eight to nine times total. Every time was in Cleveland at one of CRENSHAW's friend's houses in Cleveland. [redacted] stated that every time they engaged in sex it was consensual and without any force. [redacted] also stated that she voluntarily ingested narcotics that were offered to her.

[redacted] stated that she does not like the big age difference between the two of them. [redacted] does not want to continue to see CRENSHAW. The last time that the two of them engaged in sexual intercourse was either Tuesday, the 12th of August or Wednesday, the 13th of August. [redacted] provided a written statement.

We contacted [redacted]'s mother by phone from the detective bureau. She was advised of the situation and she spoke to her daughter over the phone.

The adult female that brought [redacted] to the station was identified as OIV/ SHANNON NELSON. She was accompanied by her niece, OIV/ [redacted] and [redacted] are good

[redacted] friends. [redacted] confided in [redacted] and NELSON about the events with CRENSHAW. NELSON advised [redacted] that she needs to report the incident with LPD. They were all advised that a report would be completed.

Dispatcher Nickler advised that on 8/16/08 she received a call from a male. The male stated that he was twenty-nine years old and he was stopped by LPD with a sixteen year old female in the car. He stated that he just wanted it noted that he believed she was eighteen years old. The male was placed on hold while dispatcher Nickler took a 911 call. The male hung up the phone before he could give his name or the name of the female.
