Topic Original Report

M.O. By using unknown force on first floor, front window, to enter an occupied residence and taking the owners property.

Sgt. Wynalek, sir,

On 08/18/2008 at 1511 hours I was detailed to 1246 Belle on the report of two black males trying to gain entry to the back of the house. Upon arrival I spoke with COM/ ROCK W. ARCHACKI, who resides at 1242 Belle. ARCHACKI advised he saw the two juvenile black males with backpacks opening the screen door of his neighbors residence of 1246 Belle. ARCHACKI then called LPD. I checked the back of the house and it appeared to be secured.

At this time Ptl. Lowther advised he saw two black males fitting the description running N/B on Belle at Clifton. Ptl. Lowther then advised he saw the males running S/B on St. Charles. Ptl. Shad advised he had one male in custody at 1221 St. Charles. Ptl. Lowther advised he had the other male in custody at 1229 St. Charles. Inv. Crumley advised he found a backpack in the backyard of 1225 St. Charles.

Ptl. Lowther identified his male as ARJ/ . was placed under arrest and into the back seat of patrol car 209. was mirandized by Ptl. Eikens. Ptl. Shad identified his male as ARJ/ . was placed under arrest and into the back seat of patrol car 214. was mirandized by Inv. Crumley.

Inv. Moher and I went back to 1246 Belle. Upon arrival we were met by OIV/ PATRICIA J. GERSON. GERSON advised she is the owner of 1246 Belle and was aware of the two black males in her backyard. GERSON stated she was in the shower about 20 minutes ago and heard her door bell ring repeatedly. GERSON also heard pounding on the front and back doors of her house. GERSON stated when she got out of the shower she looked out her back window and saw two black males. GERSON stated she asked what they were doing and one of the males said they were looking for Courtney. GERSON advised they looked surprised when she questioned them.

GERSON advised she would be able to identify the suspects if she saw them. I then transported GERSON in patrol car 204 to 1229 St. Charles. GERSON stated those were definitely the two black males at the back of her house. I then transported GERSON back to her residence. The males were unable to gain entry into GERSON's residence.

Ptl. Lowther advised was being cooperative and advised him, and himself also broke into another house on Belle. showed Ptl. Lowther the house and the address was 1186 Belle. Inv. Moher and I checked the residence and found the front window and screen open. There was no one home at this time. I left a note on the residence advising them to contact LPD.

Ptl. Eikens transported to LPD. was found with three black and mild cigars on his person. was booked into jail by C.O. Bunner and Ptl. Eikens. was charged with Aggravated Burglary and Underage Possession of Tobacco. Ptl. Eikens tagged and secured the black and milds in the property room. I issued citation #D163563 for Underage possession of Tobacco.

Ptl. Lowther transported [redacted] to LPD. C.O. Bunner and I booked [redacted] into jail. [redacted] was charged with Aggravated Burglary.

The back pack found by Inv. Crumley belonged to [redacted]. Found in the back pack was a DVD player, playstation 2 remote controller, misc. papers, \$5.10 in coins, and pens. The other back pack belonged to [redacted]. In the back pack there was a Playstation 2, Sony earphones, CD player, cell phone, X rated dvd, lighter, and screwdriver tips.

At this time we received a call from the Victims of 1186 Belle advising of what items belonged to them. Inv. Crumley spoke with the Victims and identified them as VIC/ BRADLEY S. SEFCHICK and VIC/ ERIN B. SEFCHICK. ERIN advised the DVD player, Playstation 2, and Playstation 2 remote controller belonged to her husband and her. Inv. Crumley advised the victims I would meet them at there house on Belle with their property. Inv. Crumley photographed the property belonging to the victims.

Inv. Moher and I met with ERIN and BRADLEY at there residence of 1186 Belle. All items belonging to BRADLEY and ERIN were signed for and released. Along with the other items, BRADLEY advised the X rated video and earphones belonged to him. BRADLEY signed for his property and the property was released. Inv. Moher photographed the other items belonging to the victims. Inv. Moher photographed and processed the scene. ERIN and BRADLEY advised they desire prosecution.
