Topic Original Report

M.O. By punching and slamming the VIC about the face causing physical harm.

M.O. By running from the police after being ordered to stop.

M.O. By being intoxicated, fighting with another, and running in and out of traffic placing himself and others in danger of being harmed.

On 8-18-08, at 2320 hours, Officers were detailed to Franklin/Coutant on the report of several parties fighting. On arrival, I observed VIC/ with his hands up in a defensive position and a male later identified as, ARA/DEANDRE MERRITT, with his hands up across from him. I also observed several other black males fleeing the area. MERRITT started to walk WB on Franklin. I radioed his description and INV.FIORITTO began chasing him. See INV.FIORITTO's supplement for further.

stated that he was walking WB on Franklin with his friend, VIC/DEVON YOUNGBLOOD. He advised that approx. five black males were walking EB on Franklin towards them. stated that MERRITT punched him on the right side of his face. He stated that he could not hit him back because he was too tall. advised that the other males attacked YOUNGBLOOD. observed a larger light skinned black male with "twisties" in his hair picked YOUNGBLOOD up and slammed him into the garage. stated that he learned that the male's nickname is "Bad Boy" and that his last name might be SUS/WILLIAMS.

indicated that the right side of his face hurt. He did not want medical attention. stated he desired prosecution and he provided a written statement. I did not observe any immediate injury. mother came to the scene to take home.

PO ORTIZ spoke with YOUNGBLOOD about what happened. YOUNGBLOOD advised that earlier in the day a male named wanted to fight him. He advised that he went home without anything happening.

YOUNGBLOOD indicated that a black male with braids, and four other black males came up to him and as they were walking. He advised that the male with braids punched, choked and pulled at him. YOUNGBLOOD stated that also punched him before the police arrived. YOUNGBLOOD advised that he desired prosecution.

YOUNGBLOOD left eye was swollen. He did not want medical attention. INV.FIORITTO took a photo of the injury. YOUNGBLOOD provided a statement to PO ORTIZ.

As I was conducting follow up at the intersection of Winchester/Franklin, OIV/ and OIV/CARLOS BRUTON stated that we arrested the wrong person. They advised that they showed up to the fight and that MERRITT was breaking people up. and CARLOS did not tell me why they showed up to the fight. I told CARLOS that I observed him involved in the fight. CARLOS stated that he could not refute what I had observed because he left the area as police arrived on scene. stated that he did not know if CARLOS or were involved. It should be noted YOUNGBLOOD stated that one of the males that attacked him was named

I spoke with WIT/CHRISTINE ROGERS who observed the fight from the south side of Franklin. I took a statement from her and she identified the parties by who we had stopped. She identified MERRITT because she observed that we had chased him.

ROGERS stated that she observed _____, YOUNGBLOOD and another male walking WB on Franklin. She then observed at least five other black males coming EB on Franklin from the area of Sam's Beverage. ROGERS stated that after some argument, the males started fighting. She advised that _____ was standing in the middle of the street pleading with other males not to fight. She observed MERRITT punch _____. She stated that YOUNGBLOOD was picked up and slammed into a garage by a large black male. He was then punched and kicked by several other males. MERRITT stated that if she should observe the large black male again, she would be able to identify him.

INV.FIORITTO brought MERRITT to LPD where he was booked in by P.O.PERHACS. INV.FIORITTO issued him citation #M39318 for DCI and #M39317 for Obstructing Official Business. He does not have a CCH.
