Topic Original Report

M.O.: By striking the VIC in his right eye with his fist; By choking the VIC with her arms; By kicking the VIC in the abdomen with his foot.

Sgt. Kauchek, sir:

On 8/19/2008 at 2039 hours, officers were dispatched to Kauffman Park on a call from COM/ stating parties were fighting in the park. stated those who instigated the fight left the area heading E/B on Detroit in a black Jeep with a partial plate of EHH. The area was checked for the vehicle with negative results.

Dispatch also received a call at 2134 hrs from COM/CAROLYN DUNCAN, mother of VIC/. DUNCAN stated that one of the parties involved in the park was SUS/GEORGINA LINGENFELTER. DUNCAN supplied dispatch with GEORGINA's cell phone number.

Dispatch spoke to GEORGINA on her cell phone. GEORGINA stated she was at 1495 Coutant but would return home to 1488 Olivewood to speak to officers.

Officers spoke to VIC/. stated the following: was at Kauffman Park with and OIV/. Six individuals, four W/Ms and two W/Fs, entered the park. One of the W/Fs began to accuse of attempting to sell marijuana to her son. denied the accusation. recognized one of the W/Ms as OIV/GEORGE LINGENFELTER but did not recognize any others. was holding a wooden club. One of the W/Ms, who did not recognize, told , "Shut up you stupid spic." told the male he was not a spic and the male replied, "What, are you a nigger?" and ran at and punched him in the right cheek with his fist. grabbed the male around the neck in a chokehold. An older W/M kicked in the kidney area. described this male as having a scruffy beard and a beer belly. ran home from the park, where his mother called Lakewood PD.

had a red and swollen right cheek and red marks above his right eye. Inv Pickens photographed 's injuries. requested medical attention, but when the Squad arrived, refused to be transported to the hospital.

gave a written statement and desires prosecution. stated he would recognize his attackers if he saw them again.

and gave the same account of events as stated she recognized one of the W/Ms as OIV/ who is GEORGINA's son. also stated another son of GEORGINA, OIV/ was one of the others at the park.

At 1488 Olivewood, officers spoke to SUS/GEORGINA LINGENFELTER and SUS/TODD HUNTSMAN. GEORGINA stated the following: GEORGINA's son, was at Kauffman Park earlier this afternoon. When returned home, he told GEORGINA someone at the park tried to sell him marijuana. GEORGINA went to Kauffman Park to confront the drug dealers. GEORGINA stated she

went to the park with only her sons, and OIV/ GEORGINA claimed she was not involved in a fight but others in the park were fighting and she tried to break up the fight.

HUNTSMAN matches 's description of the older W/M with a beard and a beer belly. HUNTSMAN stated he was not at the park with GEORGINA, and was eating dinner at CHAMPPS in Valley View at the time of the incident.

SUS/CHARLES TANCREDI and his wife OIV/VICKIE GRIMMETT reside at 1495 Coutant. GEORGINA spoke to dispatch from this address immediately following the incident at Kauffman Park. GEORGINA stated TANCREDI and GRIMMETT are friends of hers. TANCREDI also matches 's description of a older W/M with a beard and beer belly. The listed black Dodge Nitro OH/EHH8474 was located one house south of 1495 Coutant. The listed owner of this vehicle is GEORGINA.
