Topic Original Report

M.O. - By threatening to burn down the home of the mother of his child and his child, with them inside, causing victim to fear for her and her child's safety.

On 8/20/08, at approximately 0021 Hrs, units were dispatched to 2089 Elbur, on the report of a female receiving threatening phone calls from her boyfriend.

Upon arrival we spoke with VIC/ JENNIFER A. HYRE, who stated that she had been receiving phone calls from SUS/ LARRY D. ELLIS JR. for the last 30 minutes. JENNIFER stated that after the first few calls she answered the phone and told ELLIS that it was too late to be calling about their daughter, identified as OIV/ , and that he should stop calling. At that time, she hung up the phone.

JENNIFER stated that ELLIS continued to call, and after approximately 15 more calls she answered the phone again. This time ELLIS told JENNIFER to hold on for a minute, and JENNIFER asked what he wanted. ELLIS asked JENNIFER if she was pressing charges for an earlier property dispute, and JENNIFER stated that she was not, but she was not sure if Lakewood was. ELLIS then told JENNIFER to lie to the Lakewood police and say that she let ELLIS borrow the items he had taken. When JENNIFER told ELLIS she would not lie he got aggravated and stated that he was going to "Burn the fucking house down with you and your daughter inside." JENNIFER then stated that she heard ELLIS tell his father that he was going to burn the house down with them inside. JENNIFER then hung up the phone and called Lakewood Police.

Jennifer stated that she is extremely afraid of ELLIS and is scared he will come to the house to hurt them. It should be noted that JENNIFER also has another son living with her, from a different father, identified as OIV/ . A statement was taken from JENNIFER at her home, and she stated that she wished to prosecute in this matter. JENNIFER also stated that she wanted to get a TPO.

We contacted Elvira Smith of the Domestic Violence Center, and provided her with the required information. We also contacted Nicole Hobbs-Caraballo of 696KIDS. She was given the proper information and provided a call number of 486375 for the incident.
