<p>MO-By entering property and taking copper piping from same without permission from the owner.</p> <p>Detailed on 8-20-08 at 1023 Hrs. to 2228 Wyandotte Ave. on the report of copper piping stolen from the basement. On my arrival I spoke to COM/BRADLEY NAGY who advised the following.</p> <p>NAGY works for a company that is subcontracted out by CPY/SAFEGUARD PROPERTIES. SAFEGUARD PROPERTIES got a work order from VIC/CITIMORTGAGE to secure the residence at 2228-2230 Wyandotte as it had gone into foreclosure. The exact date the property went into foreclosure is unknown. LPD was last at the property for a Disturbance call on 6-11-08. It appears that both the upstairs and downstairs units were occupied at the time of that incident.</p> <p>NAGY advised that the first date anyone from his company responded to the property to do any maintenance was 7-28-08. At this time NAGY found the front door wide open. In further checking the home, all of the copper piping was stolen from the basement. NAGY made a report to his supervisor. His supervisor in turn made a report to CITIMORTGAGE. CITIMORTGAGE finally responded to that supervisor's report and they wanted a police report made for insurance purposes. NAGY was advised to do so today.</p> <p>Inv. Kulczycki responded to the scene for ET. Photographs were taken but no latents were found. See his photo sheet for details. NAGY was advised on the report and given the number for his records.</p> <p>It should be noted that no other point of entry could be determined at this time. It is believed that when the last tenant left the home, the front door was left unlocked.</p>
