Topic Original Report

MO-By being in possession of four small folded aluminum packets containing a substance which later tested positive for heroin.

On 8-21-08, at about 1541 Hrs., this Officer was on patrol, south of the Detroit Ave. and Coutant Ave. intersection, waiting for the light to change. At this time I observed ARA/MARK EMPING walk past me W/B with another unidentified male. This Officer had been previously advised at Roll Call that Det. McLaughlin had a Breaking & Entering warrant issued for EMPING's arrest. I then advised Dispatch on the matter and stopped the males in front of 11821 Detroit. Chief Malley, Ptl. Pietch and Ptl. Beno also arrived to assist.

I advised EMPING that he was under arrest for the B&E warrant. EMPING was then secured without further incident. In checking the ground where EMPING was stopped, several small pieces of aluminum were observed. In further checking, the aluminum was found to have been folded over and contained some type of powdered substance, believed to be heroin. Both EMPING and ARA/RICHARD MARCAURELE denied possession of the substance. MARCAURELE was advised he was under arrest for Possession of Heroin. EMPING was also advised on the additional charge. MARCAURELE was secured and placed in the rear of car 219. EMPING was then placed in the rear of car 207.

This Officer took photos of the suspected heroin and confiscated it as evidence. It should be noted, the heroin later tested positive by use of a Narkit test in the property room. The heroin was then weighed, tagged and secured in the property chute.

EMPING and MARCAURELE advised they were walking back to MARCAURELE's van which was parked in the lot at Cove Ave. and Detroit at the time of the stop. It was determined that the indexed van would also be towed incident to MARCAURELE's arrest.

EMPING and MARCAURELE were then transported to LPD and booked into Jail by Ptl. Beno and CO McCarthy. Strip searches were conducted on both males and no other contraband was located.
