Topic Original Report

M.O.:By forcing open a boarded-up basement window and entering an unoccupied house without permission.

On 8/21/08, at 1148 hours, Inv. Kulczycki, Ptl. Sidell, Ptl. Bly, Sgt. Spaetzel, and I responded to 1299 Fry Ave. on report of a male leaving the rear of the house with a duffel bag of property, headed southbound on Fry Ave. We checked the area but did not locate the male.

I checked the house and found the boards removed from the basement window at the northeast corner of the house. There was a blue shirt draped over the window frame, where there was a splintered board. The remains of the boarded-up window were on the ground outside the window frame. Looking inside the window, I saw bucket with tools inside it, along with a box that contained power tools, on the basement floor. Ptl. Sidell, Ptl. Bly and Sgt. Spaetzel checked the interior of the house, but did not locate anyone inside.

I spoke with COM/R.J. STRATTON. STRATTON said he saw the male, later identified as SUS/DAVID GLEDHILL, who he recognized as a previous resident of the house, leaving with a duffel bag which appeared to be full of property, so he asked him what he was doing. STRATTON said GLEDHILL told him he had belongings in the house, and he had the owner's permission to get them. STRATTON said he told GLEDHILL he was calling LPD, so GLEDHILL then sped away on his bicycle. STRATTON described the bicycle as a blue ten speed. STRATTON said he would recognize GLEDHILL if he saw him again. STRATTON said he knew GLEDHILL was arrested by LPD for OVI in the summer of 2007.

STRATTON went on to explain that he saw GLEDHILL leaving the house on 8/20/08 at about 1500 hours. STRATTON said GLEDHILL had the same duffel bag full of property at that time also, but he did not confront GLEDHILL. I asked STRATTON to contact LPD if he saw GLEDHILL again.

Inv. Kulczycki and I then entered the house and searched for evidence. Inv. Kulczycki processed the scene but found nothing of evidentiary value. The inside of the house was filled with piles of clothing, tools, and other miscellaneous items. We were unable to determine if anything was missing from the house at that point.

Dispatch contacted VIC/CATHERINE MAXEY, the owner of the house, and she said her friend, OIV/JOYCE PEDEN, would come and examine the house. MAXEY told dispatch that she inherited the house and lived in Arkansas, so PEDEN looked after the house for her.

PEDEN arrived and told me that she could not be sure anything was missing, due to the clutter, but she was sure someone entered the house without permission. PEDEN said that a light which was left on in the basement was not on when she was last there, and she knew the basement window was still boarded-up the last time she saw it.

PEDEN said she knew that GLEDHILL went by the name of "David" or "John," and was arrested for OVI by LPD in 2007. She was unsure of his last name, but thought it started with a "G." While I spoke with PEDEN, I found GLEDHILL's name through an address search of 1299 Fry Ave. He had an OVI arrest in July of 2007, and used 1299 Fry Ave. as his home address. When I asked if GLEDHILL's name was familiar, she said that was the name that she saw on BMV paperwork she found in the mail

I then left the house and called MAXEY. MAXEY said she did not give permission for anyone except PEDEN to enter the house. She said she desired prosecution. MAXEY said that the house was broken into in the past, see report 08005415, and some copper pipe was stolen at that time.
